General income of the U.S. Government, including taxes and customs, is credited to accounts designated by descriptive titles and symbols. Such symbols are composed of six digits: the first two are the department or agency prefix, and the remaining four are the account designation. The assigning of the department or agency prefix has only a statistical value and in no way is related to the amount that may be appropriated from general receipts for a given department or agency.

- a. The appropriations made from general receipts are the measure of the amounts that may be expended from such Department of Treasury receipts; therefore, the accounts prescribed for recording transactions may be referred to synonymously as appropriation or expenditure accounts. These accounts are designated by symbols and generally descriptive titles as follows:

0100 Taxes. Receipts from levies (other than duties or imports) under the taxing and regulatory powers of the U.S. Constitution, such as income, excise, Social Security, and immigration head taxes. The Department uses the following clearing accounts for recording payroll deductions or collections for income and Federal Insurance Contributions Act (FICA) taxes on the exception basis.

- b. When quarterly returns are made by the Department to the Director of Internal Revenue Service, receipts that have been recorded in the clearing (F) accounts are credited to the Treasury general fund account "200101 Withheld Federal Taxes." Checks against the appropriations that pay salaries are sent to Internal Revenue Service each pay period to cover taxes collected:

0800 Fees for Regulatory and Judicial Services. Fees and other charges that result from the exercise of a U.S. Government function of a regulatory or judicial nature. Include fees and charges relating to:

- (1) Application for and issuance of permits for aliens, petitions for naturalization, and papers for U.S. citizens to travel abroad;
- (2) Fees and other charges related to the application for issuance and assignment of patents, trademarks, and copyrights;
- (3) Charges for registration of individuals, firms, or products; and
- (4) Fees for filing or recording documents.

(TL:FMH-1; 04-15-1994)

- a. Under authority of section 601 of the Economy Act of June 30, 1932 (31 U.S.C. 686), funds may be advanced from the accounts of one U.S. Government department or agency to another to cover the estimated cost of services, supplies, or materials to be furnished. Symbols of working funds are assigned according to receiving agencies and fiscal years under the three classes of funds:
- (1) General;
 - (2) Special; and
 - (3) Trust.
- b. A given agency may have need for several working funds. Advances from a certain appropriation within a fund group will be identified by a decimal suffix to the basic working fund symbol. The symbol of a working fund, which under General Regulations No. 84 is assigned by Department of Treasury in each case, will consist of the department or agency prefix; the digit, digits, or "X" denoting the fiscal year status; and four digits indicating the account within the range for the classification involved.
