On May 13, 2002, The President signed into Law the "Farm Security and Rural Investment Act of 2002," also known as the Farm Bill, which has now become Public Law 107-171. Section 6031 of the Farm Bill, provides \$360 million to fund water and waste disposal applications pending on the date of enactment, May 13, 2002.

This document is a listing of applications pending on May 13, 2002, which meet the requirements for Section 6031 of the Farm Bill. Please note that the monies provided for in Section 6031 will only fund a small portion of the projects listed.
