> > breaches of the 3000' ceiling that is meant to protect the
> > OCNMS. My home is at 80' in the cliffs and it is common place
> > for small planes and helicopters to fly below the cliffs. This
> > year alone, I have witnessed airplanes flying between bald
> > eagles, fly up from the beach below the tree level, use the
> > level below the cliffs as a flyway, land on the beach and
> > helicopters fly up Joe's Creek below the cliff levels and just
> > over the highway. . While I have called the local law
> > enforcement offices they refer me to the FAA who is is not
>> available on the weekends. There are no managers at the airport
> > between Olympia and the beach environs so there is no
> > responsible part to contact. In addition, there is a registered
> > FAA airport, on the beach, within the OCNMS, that is managed and
> > sanctioned by the State of WA, that also is the fly over for a
> > State Park where sea birds nest and marine mammals use as
> > habitat. To date:
> > o I have yet to hear of any attempt by agencies to shut down
> > the airport.
> > o Enforce the flight floor by using monitoring stations,
> > press or notices to airports or pilots, or intervention by
> > radar available from the Pacific Beach Navy Base.
> > * There continues to be considerable use of the beach environs as
> > transportation by motorized vehicles. While it is the policy of
>> the State of WA to designate the beaches as "highways", there is
> no enforcement, no standard road signs for speed, no protection
> > for pedestrians (four or two legged) from vehicle aggression and
> > any vehicles that get stuck in the sand are left to sink. There
> > are considerable photos of these events and the debris is now
> > bleeding or leaching by-products into the waters of the ONCMS.
> > In the process to possibly deter, eliminate or just control
> > driving in the beach environs, I designed and copyrighted
> > "Think. Don't Drive in the Drink". It is a graphic that was
> > generally accepted by local subdivisions and even local
  > politicians - the OCNMS would only have to support its use for
> > communities and counties to adopt its use. It promotes
> Sanctuary and public safety. I have never heard of the State of
> > WA, the OCNMS or any county - issuing any fine or violation of
> > the beach environs by abandonment of vehicles.
> > * There is considerable deforestation along the south end of the
> > OCNMS. In some cases this is from mass subdivision development,
> > resubdivision of larger lots and by speculators of future
> > development. I do not know of the OCNMS being part of the
> > review process for any of this activity or notifying any
