M/V Cosco Busan Oil Spill – City and County of San Francisco Timeline of Events

The container ship M/V *Cosco Busan* struck the Bay Bridge in the San Francisco Bay at 08:27 PST on 7 November 2007. An approximate 100' gash in the hull of the vessel resulted, and 58,000 gallons of fuel oil (IFO 380) were released into the water.
