# INSTRUCTIONS FOR PETITIONERS APPLYING FOR ENROLLMENT TO PRACTICE IN THE UNITED STATES DISTRICT COURT, EASTERN AND WESTERN DISTRICTS OF ARKANSAS

## **IN-STATE PETITIONERS**

To be admitted to practice in the United States District Court for the Eastern and Western Districts of Arkansas, a written petition must be filed with the Clerk of Court. For this purpose, the attached *Petition for Enrollment* must be completed.

Each petitioner is required to answer all questions on the *Personal History Statement*. This information is necessary for the court to determine your qualifications. The statement must bear your signature(s) and be acknowledged before a Notary or other official authorized to administer oaths.

In addition, your *Petition for Enrollment* must be accompanied by an <u>original</u> *Certificate of Good Standing* from the Clerk of the Arkansas Supreme Court.

Your *Petition for Enrollment*, *Personal History Statement*, and *Certificate of Good Standing* must be accompanied by <u>two separate checks</u> - a \$150.00 attorney admission fee and a \$5.00 annual assessment for the "Library Fund" fee <sup>1</sup>, pursuant to Local Rule Appendix XI - and should be mailed or presented to the United States District Court where you intend to practice.
