

IRS TO OFFER SATURDAY WALK-IN SERVICE AT NEARLY 250 LOCATIONS

WASHINGTON -- Delivering on its promise to supply even more reliable and helpful taxpayer assistance, the Internal Revenue Service will provide Saturday walk-in service during the 1999 filing season at nearly 250 locations nationwide. Assistance with tax law questions and tax return preparation is free.

IRS representatives will be on hand to assist taxpayers on 13 Saturdays from January 16 through April 10. Help will be available from 8:30 a.m. to 12:30 p.m.

"The expanded walk-in hours and an around-the-clock toll-free help line reflect our commitment to provide top quality customer service," said IRS Commissioner Charles Rossotti. "Whether it is in person or on the phone, we want to answer your questions correctly, promptly and courteously."

The first six Saturday sessions will focus on assisting low-income taxpayers who may be eligible for the earned income tax credit (EITC). Taxpayers may be able to claim the EITC if they earn less than \$10,030 and have no qualifying children, less than \$26,473 and have one qualifying child, or less than \$30,095 and have more than one qualifying child.

Taxpayers who wish to receive tax preparation assistance should bring all relevant income and tax data with them. This may include copies of wage and tax statements (Form W-2), information returns showing interest, dividends or other income received (Form 1099), information showing mortgage or other deductible interest paid out (Form 1098), and the employer identification number (EIN) of any child care provider used. In addition, taxpayers must have valid Social Security Numbers (SSNs) for themselves and any dependents they claim. Joint returns must be signed by both spouses.

The 24-hour toll-free line and the IRS Web site (www.irs.ustreas.gov) are additional sources of free tax products and assistance. Some of the most requested tax forms, instructions and publications are also available at many post offices and libraries.
