Obtaining Event-Usage Lists from ICMS Courts

As part of the docketing survey, we asked the districts that docketed cases terminated in calendar 2002 in an ICMS case-management database to send information on internal docketing codes.

Courts responded either by transmitting code lists kept for internal management purposes or by running an event-usage report, available from the Systems Deployment and Support Division of the AO (SDSD), that would produce code information. Most courts elected to run the event-usage report. Initial response to the request was high and, after follow-up efforts, all but one of the 69 courts that sent ICMS case data also sent code information.

Courts sent three kinds of docketing code reports: event codes, relief codes, and order-action codes. The reports provided a listing of all of the numeric codes used in docketing the particular category of information (i.e., events or reliefs) along with a text description of what the code represented (e.g., event code 442 indicates the filing of a “motion,” relief code 114 indicates the relief requested was “for summary judgment,” and order action code 4 indicates the motion was “granted”). The standard report format generated by the SDSD program also included a usage count for each code that helped us distinguish common codes from those rarely used. Examples of the three event-usage reports are attached.
