

- Identify scope, schedule, and cost for common R&D
- Recommend common R&D priorities
- Contribute sections to R&D Scope Reports
- Prepare reports on specific issues as needed
- Write Joint R&D Planning Report with input from TWGs

- Four additional crosscut groups began work in November 2001
- FCCG, RSCG, and ECG provided initial comments on concept evaluation consistency
- Now focusing on one concept for each TWG (IPSR, GFR, Na metal pyro B, GCR)
- Preparing for upcoming conference call and meetings
- Playing essential roles to ensure high quality Roadmap
