JOINT APPLICATION OF AEROVIAS DE MEXICO, S.A. DE C.V. AND AEROLITORAL, S.A DE C.V. FOR EXEMPTION AND <u>CODE SHARE STATEMENT OF AUTHORIZATION</u>

Pursuant to 49 U.S.C. § 40109(c) and 14 C.F.R. Part 212, Aerovias de Mexico,

S.A. de C.V. ("Aeromexico") and Aerolitoral, S.A. de C.V. d/b/a Aeromexico Connect ("Aerolitoral") (collectively, the "Joint Applicants") respectfully request that the Department grant the following authorizations to permit the Joint Applicants to expand their Mexico-U.S. code-share/blocked space services:

a. Exemption authority for one year to Aeromexico to the extent necessary to permit it to engage in scheduled foreign air transportation of persons, property and mail between Hermosillo, Mexico, on the one hand, and Albuquerque, New Mexico, San Francisco and San Diego, California, on the other, by displaying its "AM" code on flights operated by Aerolitoral. Aeromexico currently holds exemption authority to provide service between Chihuahua, Mexico, and Albuquerque, New Mexico in Docket OST-2008-0028.

b. Exemption authority for one year to Aerolitoral to the extent necessary to permit it to engage in scheduled foreign air transportation of persons, property and mail between (1) Hermosillo, Mexico, on the one hand, and Albuquerque, New Mexico and San Francisco and San Diego, California, on the other, and (2) Chihuahua, Mexico, and Albuquerque, New Mexico.

c. Statement of authorization for an indefinite period to permit Aerolitoral to display Aeromexico's "AM" designator code on flights operated by Aerolitoral on the routes listed in paragraph (b) above.

It is intended that the daily nonstop service be commenced on September 1, 2008 with regional jet aircraft.

In support of this application, the Joint Applicants state as follows:

1. Aeromexico is a flag carrier of the United Mexican States and currently holds a foreign air carrier permit, which authorizes service between Mexico and numerous U.S. points. Order 91-5-25. Pursuant to its permit and various exemption authorities, Aeromexico provides extensive service between Mexico and the United States, with some of that service being provided under its code sharing agreement with Aerolitoral.

2. Aerolitoral is a flag carrier of the United Mexican States and currently holds exemption authority, which authorizes service between Mexico and a number of U.S. points. Pursuant to that authority, Aerolitoral generally provides service between Mexico and the United States under Aeromexico's "AM" code. 3. By this application, Aeromexico seeks exemption authority to provide air service between Hermosillo, on the one hand, and Albuquerque, San Francisco and San Diego, on the other, by displaying its "AM" code on flights operated on those routes by Aerolitoral. It also intends to serve the Chihuahua-Albuquerque market, for which it currently holds exemption authority, by displaying its code on Aerolitoral flights.

4. Annex 1 to the 1960 Air Transport Agreement, as amended, between the United Mexican States and the United States, provides that a carrier designated by the Government of Mexico is entitled to operate "[f]rom a point or points in Mexico to a point or points in the United States." By letter dated February 27, 2008, a copy of which is attached, the Direccion General de Aeronautica Civil requested that the Secretaria de Relaciones Exteriores designate Aerolitoral under Annex I for the four routes in question. Similarly, by letter dated May 27, 2008, a copy of which also is attached, the Direccion General de Aeronautica Civil requested that pursuant to Annex III, the Secretaria de Relaciones Exteriores notify the U.S. that Aeromexico had been authorized to serve the routes in question by displaying its code on flights operated by Aerolitoral. Consequently, the exemption and code share authorization are consistent with the agreement and, therefore, the public interest.

Moreover, the benefits which the new service will generate for business travelers, tourists, and shippers alike further demonstrate that the exemption and code share are consistent with the public interest. The proposed service will improve the available air service and facilitate travel in the Mexico-U.S. market to the benefit of the public.
