The list of imported products subject to veterinary inspection when crossing the border of the Russian Federation is herewith translated into English for the information of exporters and other interested parties.

Overview

This report reproduces in English translation the list of imported items subject to veterinary inspection when crossing the Russian Federation border. They are listed for the most part in order of commodity code number (heading) as defined in the Russian tariff nomenclature, known as the TN VED ("tariff nomenclature for foreign economic activity").

While the Russian tariff nomenclature has much in common with the harmonized system, TN VED and HS codes do not coincide perfectly. In addition, some of the headings in this document bear the descriptor "from", meaning not all items under that heading are necessarily subject to veterinary inspection. In these cases, traders should refer to the article description for clarity.

As a rule, imported products subject to veterinary inspection are required to be accompanied by an appropriate health certificate; it is the responsibility of exporters to ensure that any required certificates and other documents are obtained and that they accompany the shipment.
