SMALL GRANTS WITH BIG IMPACT IN CENTRAL PROVINCE

As part of a swing through central Province last week, Ambassador Donald E. Booth and USAID Director Melissa Williams dropped in on two Kabwe-based Democracy

and Human Rights Fund (DHRF) 2007 grantees.

The next stop was to Shamabase Compound on the outskirts of Kabwe, where the balance of a DHRF grant was presented to Mainza Sikana, program coordina-

tor at Community Action Against HIV/AIDS (CAHA). Ambassador Booth also announced that CAHA was to receive a PEPFAR grant for \$15,485.

Acknowledging the efforts of CAHA in reaching out to orphans and vulnerable children, Ambassa-
