Thanks for following up our Camp discussion.

UM is interested in finding a way for Dilbert and Netscape to work together. Unfortunately, the models that come to mind are borrowed from your competitions ideas but nonetheless, here they are.

1) We could work together where in www.unitedmedia.com becomes a showcase site for Netscape technology. You would give us technical support, software, and prominent placement on the Netscape home page and we would, with your help, develop www.unitedmedia.com site enhancements to showcase what your technology can do and give you prominent placement on our enhanced pages. For the record, MS IE is offering this kind of deal and also talking about \$.
