The following profile contains information on demographics, political figures, funding, programs, crime, drug use, drug trafficking, and enforcement statistics.

Demographics

- Population (2005 American Community Survey): 1,144,946¹
- ➤ Race/Ethnicity (2005 American Community Survey): 56.9% white; 23.7% black/African American; 0.5% American Indian/Alaska Native; 2.8% Asian; 0.0% Native Hawaiian/other Pacific Islander; 15.0% some other race; 1.2% two or more races; 42.1% Hispanic/Latino (of any race)²
- ➤ The city of Dallas is located in Collin, Dallas, and Denton counties.³

Programs/Initiatives

- ➤ High Intensity Drug Trafficking Areas (HIDTA)¹¹
 Designated in 1998, the North Texas HIDTA is responsible for Counties in Oklahoma and Texas, including Collin, Dallas and Denton Counties.
- ➤ Greater Dallas Council on Alcohol and Drug Abuse (GDCADA)¹²
 Since the council was founded in 1946, it has developed campaigns to reduce the incidence and impact of alcohol and drug abuse. Some of the GDCADA services and programs include education classes for drug and DWI offenders, school-based prevention programs, a prevention resource center, and community service/restitution programs.

Crime and Drug-Related Crime

➤ During 2006, there were 184 homicides known to police in Dallas¹³

Drugs

Cocaine

A gram of powder cocaine sells for \$50-\$80 and an ounce of powder cocaine sells for \$600-\$950 in Dallas. Throughout the Dallas metropolitan area, crack cocaine remains popular and easily attainable. An ounce of crack cocaine sells for \$700-\$1,100 in Dallas. 17

> Heroin

Intelligence indicates an increase in the availability of Colombian and Southwest Asian heroin in the greater Dallas area. ¹⁸ In the Dallas area, black tar heroin is readily available and its purity is increasing. An ounce of black tar heroin costs \$1,000–\$1,500 and Mexican brown heroin sells for \$800-\$1,600 per ounce in Dallas. Colombian heroin sells for \$10 per cap, \$2,000 per ounce, and \$65,000-\$80,000 per kilogram. ¹⁹

> Marijuana

Mexican Marijuana is readily available in the Dallas area, although there are continuing seizures of domestically grown marijuana. High quality sinsemilla sells for \$900–\$1,200 a pound in the Dallas/Fort Worth area. Canadian "BC Bud" sells for \$2,900-\$3,100 in Dallas. Commercial grade marijuana sells for \$350-\$800 per pound. ²⁰

> Methamphetamine

Recent intelligence and seizure analysis indicates an increased availability of high purity methamphetamine in the Dallas/Ft. Worth area. An ounce of domestic methamphetamine sells for \$600-\$800, an ounce of Mexican methamphetamine sells for \$400 and an ounce of ice sells for \$1,400 in Dallas.

Club Drugs

The abuse of ecstasy among 18 to 24 year old African Americans in the greater Dallas area appears to be on the rise. Single dosage units of ecstasy sell for \$12–\$20 in Dallas. The price of GHB has increased from \$100–\$200 per gallon in 2005 to \$500–\$1,600 per gallon in 2006 and a dose of GHB costs \$20. A dosage unit of LSD

- sells for \$1–\$10 and PCP sells for \$375–\$450 per ounce, \$25 per cigarette, and \$10 for a piece of a "sherm" stick in Dallas. ²⁴
- ➤ Diverted Pharmaceuticals²⁵
 In the Dallas area, there is an increase in the use of Xanax and Valium among methadone clients.
- > Other Drugs²⁶
 - "Cheese" or "starter heroin" is a combination of heroin and ground up cold medicine containing acetaminophen and diphenhydramine. This mixture was found at several Dallas middle and high schools in 2006.
- ➤ According to 2002-2005 data from the National Survey on Drug Use and Health (NSDUH), approximately 6.5% of Dallas metropolitan area residents (ages 12 or older) reported past month use of an illicit drug. ²⁷

Juveniles

➤ During 2005, 6% of Dallas high school students reported using methamphetamine at least once within their lifetime. ²⁸

Enforcement

- ➤ As of October 31, 2005, there were 3,518 law enforcement employees in Dallas (2,970 officers and 548 civilians). ³⁰
- ➤ Dallas Police Department Narcotics Division³¹
 The Narcotics Division of the Dallas Police Department consists of four units, including Street Level Enforcement; Mid and Upper Level Enforcement; Federal Task Force; and Airport Interdiction.

Trafficking and Seizures

- ➤ The greater Dallas/Fort Worth area primarily serves as a drug distribution and transshipment area. Drug smuggling and transportation are dominated by major Mexican trafficking organizations. These groups are poly-drug organizations smuggling methamphetamine, heroin, cocaine, and marijuana to the Dallas/Fort Worth area for distribution in the Eastern, Southeastern, and Midwestern United States. ³²
- ➤ Intelligence indicates that organizations operating on the East Coast are interested in setting up an operation in the greater Dallas area in order to obtain reliable supplies of cocaine at a lower price than what they pay on the East Coast.³³
- ➤ The Dallas metropolitan area serves as the primary distribution point for crack destined to outlying areas in North Texas as well as the states of Oklahoma, Louisiana, Arkansas, and Mississippi.³⁴
- ➤ The greater Dallas/Fort Worth area is a distribution point for Mexican black tar heroin shipped to the Eastern, Southeastern, and Midwestern United States. 35
- ➤ Intelligence indicates increased interest among Mexican traffickers to distribute and sell Ecstasy in the Dallas/Fort Worth area.³⁶

Courts

- ➤ Drug Courts³⁷
 - As of November 22, 2006, there were 5 drug courts in Dallas that had been operating for over 2 years and an additional 3 drug courts had recently been implemented. There were no additional drug courts in existence or being planned at that time.
- ➤ During FY 2005, 26.1% of the Federally-sentenced defendants in Northern Texas were charged with committing a drug offense. Methamphetamine was involved in more than 20% of the drug cases.³⁸
