- When our Chapter decided to petition for this award, we believed we deserved it. But then came the hard part of proving it, which was placed in the hands of a dedicated

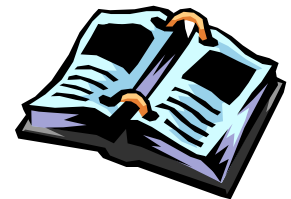
