#### **ADMINISTRATIVE ORDER**

WHEREAS, the government has filed a motion pursuant to Local Rule 9.03(B) seeking approval of a revised schedule of collateral subject to forfeiture in relation to petty offenses and misdemeanors prosecuted by citation or violation notice, affecting federal properties administered by the National Park Service at the Jefferson National Expansion Memorial at St. Louis, Missouri and the Ozark National Scenic Riverways at Van Buren, Missouri. AND WHEREAS, the court finds that the schedule is in compliance with law and that no collateral amount exceeds the maximum fine authorized by law upon conviction for a listed violation.
