BACKGROUND

OBJECTIVE

OFFICE OF HEALTH, INFECTIOUS DISEASE AND NUTRITION (<u>TWO</u> INTERNSHIPS)

The Office of Health, Infectious Diseases and Nutrition (HIDN) manages a diverse portfolio within the Bureau for Global Health (GH) through the work of four divisions: Nutrition, Health Systems, Infectious Diseases, and Maternal and Child Health. It is responsible for sector-wide strategic planning; technical leadership; coordination with external partners; and numerous operational programs in child survival, maternal health, nutrition/micronutrients, infectious diseases, environmental health, health policy, and health systems strengthening, monitoring, reporting, and performance management.

Internship No. 1 – Nutrition Division Health Analyst (graduate-level preferred)

Introduction

The intern is assigned to the Nutrition Team of the Bureau for Global Health, Office of Health, Infectious Disease and Nutrition, Division of Nutrition.

The Nutrition Division is comprised of 14 professionals with a wide range of technical expertise and experience. The Division is responsible for technical leadership and direction in food and nutrition. Division teams focus on infant feeding and breastfeeding, micronutrients, food supplementation, and applied nutrition programming in the public, private and nonprofit sectors. Additionally, the Division houses the Child Survival and Health Grants Program which works closely with US-based PVOs in the areas of health, infectious disease, nutrition and reproductive health.

The intern will serve primarily as a program analyst/assistant for the Nutrition Team, but may also carry out other Bureau-wide duties and collaborative research with other analysts in the Bureau. S/he will be supervised by the Division Chief, but will work closely with the entire team, including the Senior Nutritionist and colleagues from the Bureau for Global Health.

Qualifications

Qualified candidates will have completed at least one semester in an accredited MPH program and/or graduate program related to health. The applicant should possess writing skills and experience in research and analysis, including some experience (and comfort) in working with data.

Duties and Responsibilities

- 1. Assist the Nutrition Team in managing on-going regional projects and providing support to USAID mission-managed health activities, particularly in regards to analysis and dissemination of information related to regional health trends.
- 2. Working with the Division Chief and Senior Nutritionist to revise strategies and monitoring and evaluation of nutrition programs.
- 3. Prepare charts, briefing memoranda, position papers, correspondence and other analytical work as requested.
- 4. Attend programmatic-related events within and outside USAID as requested.

Internship No. 2 – Health Systems Division Health Analyst (graduate-level preferred)

Introduction

The intern is assigned to the Health Systems Division (HSD) within the Office of Health, Infectious Diseases, and Nutrition. The HSD Team manages the global health systems projects in the areas of policy, financing, drugs, insurance schemes, human resources, and information systems. The intern will serve primarily as a research analyst/assistant for the HSD Team, but may also carry out other Bureau-wide duties and collaborative research with other analysts in the Bureau. S/he will be supervised by the Public Health Specialist Analyst, but will work closely with the entire team, including the Division Chief.

Qualifications

The applicant will be enrolled in a graduate program related to health. Qualified candidates will have writing skills, and experience in research and analysis, including some experience (and comfort) in working with data.

Duties and Responsibilities

OFFICE OF POPULATION AND REPRODUCTIVE HEALTH (ONE INTERNSHIP)

The Office of Population and Reproductive Health (PRH) strategic objective is to advance and support voluntary family planning and reproductive health programs worldwide. To achieve this objective, USAID's Office of Population & Reproductive Health:

- Exercises global leadership in policy, advocacy and services
- Generates, organizes and disseminates knowledge
- Provides support to the field for implementing effective programs

PRH provides leadership in population and family planning and related reproductive health services; manages a large portfolio of technical assistance, training, and communication projects that support field programs; procures contraceptives and HIV/AIDS condoms; directs biomedical, social science, and operations research activities that address long-range needs and pertinent issues affecting the field; and provides scientific and technical input needed to ensure high-quality standards of practice for USAID family planning and reproductive health programs. This Office is comprised of four divisions: Commodity Security and Logistics; Policy, Evaluation and Communication; Research, Technology and Utilization; and Service Delivery Improvement.

Internship No. 3 – Policy, Evaluation and Communication Division Health Analyst (graduate-level preferred)

Introduction

The intern is assigned to the Policy, Evaluation and Communication (PEC) division of the Office of Population and Reproductive Health (PRH) in the Bureau for Global Health (GH).

The Policy, Evaluation and Communication division portfolio encompasses nine projects with annual funding in excess of \$90 million. The Division supports improved collection, analysis, and use of data in policymaking and program planning; and promotes policies, behavior change, and community norms that result in improved reproductive health outcomes. In addition, leadership of the Bureau's support for gender, population-health-environment, poverty-equity and reproductive health for refugees initiatives is housed in PEC. PEC Division activities contribute to the Agency's goal of stabilizing world population growth and protecting human health primarily through family planning, but also through supporting initiatives in maternal health, child health, HIV/AIDS, and infectious diseases.

The intern will serve primarily as an analyst/program assistant for the PEC Division, working specifically with the Population-Environment Team,

http://www.usaid.gov/our_work/global_health/pop/techareas/environment/index.html. S/he will be supervised by the Division Chief, but will work closely with the division and other colleagues from PRH.

Oualifications

Qualified candidates will have completed at least one year in an accredited graduate-degree program (PhD preferred) and possess writing and communication skills, experience in research and analysis,

and some ability to analyze budgets. Specifically, advanced statistical analysis skills are required, including principal component analysis, factor analysis, logistic regression, and stepwise regression models. Familiarity with STATA (preferred) or similar data analysis program is necessary. Finally, professional and academic interest in linking reproductive health, population, and environment is preferred.

Duties and Responsibilities

- 1. Conduct a literature review of peer reviewed and published academic literature linking population, health, and environment (PHE) and demonstrating the benefits of linking PHE. Complete a report summarizing literature review of peer reviewed literature on linking population, health, and environment
- 2. Conduct advanced statistical analysis of data sets from the Environmental Health Project (EHP) in Madagascar. The data set includes data on key health and environment indicators in project sites with and without an integrated population, health, environment intervention. The intern will need to:
 - Analyze the data sets and variables in order to determine what mode of analysis is most applicable, building on the analyses already performed (which are outlined in the EHP end of project report, which will be given to the intern). Explore whether difference-indifference analyses and propensity score matching would be appropriate to evaluate overall program impact. Present data analysis approach for approval.
 - Conduct advanced statistical analysis of the data according to the approved analysis
 approach in order to determine whether or not there were statistically significant benefits
 to implementing project activities in an integrated fashion versus a non-integrated
 fashion.
 - Summarize results in a report.
- 3. Assist Population-Environment technical advisor to plan for USAID management reviews of World Wildlife Fund and Conservation International's Population-Health-Environment projects.

OFFICE OF HIV/AIDS (ONE INTERNSHIP)

The U.S. government has made the fight against HIV/AIDS a top priority, not only for humanitarian reasons, but because the HIV/AIDS crisis threatens the prosperity, stability, and development of nations around the world. USAID has funded almost \$6 billion since inception of its international HIV/AIDS program in 1986, more than any other public or private organization. USAID currently has HIV/AIDS programs in nearly 100 countries worldwide. These programs are managed by the Office of HIV/AIDS (OHA). OHA is also a major implementing partner in the President's Emergency Plan for AIDS Relief, the largest commitment ever by a single nation toward an international health initiative. The Emergency Plan is a five-year, \$15 billion, multifaceted approach to combating HIV/AIDS in more than 120 countries around the world.

Internship No. 4 – Strategic Planning, and Implementation and Support Divisions Health Analyst (graduate-level preferred)

Introduction

The intern will work in the Office of HIV/AIDS (OHA), Strategic Planning, Implementation and Support Division (SPER). S/he will work with two senior SPER staff members who have responsibilities for human capacity building, health systems strengthening and training, and the other Global Fund for HIV/AIDS, Tuberculosis and Malaria (GFATM). S/he will be supervised by one of these staff members, but will also be available to undertake tasks collaboratively with the other colleagues in the Office of HIV/AIDS and the Office of the Global AIDS Coordinator.

Qualifications

Qualified candidates will have completed at least one semester in an accredited MPH program or in a graduate program related to health, possess excellent written and oral communication skills, and be able to undertake guided analysis and research related to human capacity building and health systems strengthening issues.

Duties and Responsibilities

- 1. Work with the Human Capacity Development staff member, assist in researching and analyzing information related to President's Emergency Plan for AIDS Relief and the GFATM's work to date in supporting health systems strengthening and human capacity building.
- 2. Work with the GFATM staff member and the Interagency Global Fund Core Group to help conceptualize and put in place a process for monitoring outcomes of the Global Fund technical assistance being provided by USG entities.
- 3. Prepare charts, briefing memoranda, position papers, correspondence and other analytical work as requested.
- 4. Attend meeting and other events related to systems strengthening and capacity building for HIV/AIDS and the GFATM.

BASIC REQUIREMENTS AND SELECTIVE FACTORS:

- Applicants must be American citizens (or permanent resident status).
- Applicants must be enrolled in undergraduate or graduate school (preference given to graduate-level students). Students graduating in May 2007 are also invited to apply.
- Applicants should be studying relevant disciplines with a health emphasis.
- Flexibility, initiative, enthusiasm, good interpersonal skills and energy are desired traits.
- Computer skills are a necessity.

QUALITY RANKING FACTORS (QRFs):

QFRs determine the ranking of qualified candidates in comparison to other applicants. They are:

QRF #1: Relevant educational and/or work experience including experience in or familiarity with

international public health issues. Preference given to graduate-level students.

QRF#2: Goals and interests as they relate to USAID's mission.

QRF#3: Analytical capacity.

QRF#4: Written and oral skills.

BASIS OF RATING:

Applicants who meet the basic qualifications and selection factors will be further evaluated based on the quality ranking factors. Applicants are required to submit:

- 1. A Letter of Interest **identifying the <u>specific</u>** internship being applied for (e.g., "Internship No. 1 Nutrition Division Health Analyst") and addressing the Basic Requirements and Selective Factors and the Quality Ranking Factors (QRFs) listed in the solicitation, page 12.
- 2. A resume or Curriculum Vitae.

The <u>acceptable file type</u> for submitted documents is Microsoft's Word (.doc) or Adobe's Acrobat (.pdf).

The most qualified candidates will be contacted by phone and interviewed in person, if possible. It is also possible that reference checks may be conducted on those candidates selected for an interview.
