New Definitions included in the new incident reporting rule

<u>Collision</u> means the act of a moving vessel (including an aircraft) striking another vessel, or striking a stationary vessel or object (*e.g.*, a boat striking a drilling rig or platform).

<u>One or more days</u> means the injured person was not able to return to work or to all of their normal duties the day after the injury occurred.

Loss of well control means:

(i) Uncontrolled flow of formation or other fluids. The flow may be to an exposed formation (an underground blowout) or at the surface (a surface blowout):

- (ii) Flow through a diverter; or
- (iii) Uncontrolled flow resulting from a failure of surface equipment or procedures.

Property or equipment damage means the cost of labor and material to restore all affected items to their condition before the damage, including, but not limited to, the OCS facility, a vessel, helicopter, or equipment. It does not include the cost of salvage, cleaning, gas-freeing, dry docking, or demurrage.

<u>Structural damage</u> means damage severe enough so that operations on the facility cannot continue until repairs are made.

Information required in the new incident reporting rule for the immediate oral notification to the District Manager

- 1) Date and time of occurrence
- 2) Operator, and operator representative's, name and telephone number
- 3) Contractor, and contractor representative's name and telephone number (if a contractor is involved in the incident or injury/fatality)
- 4) Lease number, OCS area, and block
- 5) Platform/facility name and number, or pipeline segment number
- 6) Type of incident or injury/fatality
- 7) Operation or activity at time of incident (*i.e.*, drilling, production, workover, completion, pipeline, crane, etc.) and
- 8) Description of the incident, damage, or injury/fatality.

Information required in the new incident reporting rule for the written reports submitted to the District Manager

Items 1) through 5) and item 7) are the same as for the oral notification listed above.

- The following items are also required:
 - 6) Type of incident or injury
 - 8) Description of incident, damage, or injury (including days away from work, restricted work or job transfer), and any corrective action taken and
 - 9) Property or equipment damage estimate (in U.S. dollars).

Operators may submit a report or form prepared for another agency if the report or form contains all the information required by MMS.

The District Manager may require submission of additional information about an incident on a case-by-case basis.
