\*A **DOE Recordable** case is an occupational injury or illness that requires more medical treatment than simple first aid and so must be reported to DOE as per the Performance Evaluation Measurement Plan (PEMP).

A **DART** case is a subset of DOE Recordable cases, whereby the injury or illness is severe enough that an individual loses time away from their job by being away from work, by being on restricted duty, or by being transferred to another job function.

First Aid Cases are those which specifically meet the criteria established by OSHA 29 CFR 1904.7(b)(5)(ii).
