Dear Ms. Weidner:

Per our telephone conversation Drs. Geller and Wolfson are only authorized to use radioactive materials specified in 10 CFR 35.100 and 10 CFR 35.200. Therapeutic administration of radiopharmaceuticals will not be performed by these physicians. I understand that you have copies of their American Board of Radiology certificates; therefore you have evidence that these physicians meet the respective training requirements of Subpart J.

In vitro assays (radioimmunoassays) are performed at St. Christopher's Hospital for Children in the Clinical Laboratories. Although the tests are of the type that are generally licensed in 10 CFR 31.11 (which only requires registration with the NRC), we may on occasion possess more than 200 μ Ci at any one time. Barbara Goldsmith, Ph.D., was the authorized user for these activities while they were conducted under the Temple University license. Dr. Goldsmith will continue as the authorized user for these activities.

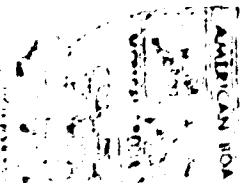

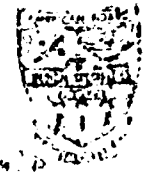
