In accordance with the provisions of Para. (A) of Article (42) and Para. (D) of Article (43) of the constitution,

The Revolutionary Command Council have decided to promulgate the following Law :-

LAW No. (77) OF 1989

**RATIFICATION OF MEMORANDA
EXCHANGED BETWEEN THE GOVERNMENT
OF THE REPUBLIC OF IRAQ AND THE
GOVERNMENT OF THE REPUBLIC OF
TURKEY CONCERNING THE PROLONGING
OF ENFORCEMENT PERIOD OF THE
ACCORD CONCLUDED BETWEEN THEM
ON PROPERTIES AND ESTATE RIGHTS**

Article - 1 -

The two memoranda exchanged between the Government of the Republic of Iraq and the Government of the Republic of Turkey Nos. 7/3/4/9/265 of 9.7.1989 and 504 of 5.5.1989, concerning the prolonging of enforcement period of the Accord concluded between them regarding properties and estate rights, which has been ratified by Law No. (53) of 1984, for two years beginning from the expiry date of the said accord on 11.3.1990, shall be ratified.

Article - 2 -

Both aforementioned Memoranda in Article (1) of this Law shall be considered part and parcel of the said Accord.

Article - 3 -

This Law shall be published in the Official Gazette and the competent Ministers shall undertake the execution of its provisions.

In accordance with the provisions of Para. (A) of Article (42) of the Constitution,

The Revolutionary Command Council have decided the following :-

First - Occupiers of houses rented for purposes of the Opera House Project, situated between Al - Junihooriya Bridge and Mansoor Melia Hotel, in Baghdad, shall be given a six - month - period of grace in order to evacuate them as from the date of notifying them of the evacuation by the competent authority

Second - Courts of law shall be prohibited from hearing actions arising from the application of this Resolution.

Third - This Resolution shall be published in the Official Gazette; Minister of Culture and Information, and Minister of Justice shall undertake the execution thereof.
