The following is Mexico's current import tariff schedule. As stated above, the descriptions are unofficial translations completed by FAS/Mexico. They reflect all the known additions, changes, and/or deletions to the schedule since NAFTA was signed. The most important of these was when Mexico published its entire schedule on December 18, 1995.

The tariffs shown are those that went into effect January 1, 2001, and will remain in effect until December 31, 2001, and are limited to merchandise from the United States. These tariffs, but not the descriptions, were published in Mexico's "*Diario Oficial*" (Federal Register) on December 29, 2000.

Explanation of the special tariffs ("ES",) and Notes ("C", "NZ", "N", "M", "S", "Q", "FAS") follow after this schedule in the APPENDICES.

 - b) bamboo nor other natural woody materials of the species used primarily in basketware or esparto, raw, including split, sawn lengthwise or cut in set lengths. (Heading 14.04);
 - c) wood shavings and slivers nor ground or pulverized wood, from the species used primarily for dyes or tanning agents (Heading 14.04);
 - d) activated charcoal (Heading 38.02);
 - e) the products under Heading 42.02 (for example: trunks, suitcases, vanity cases, etc.)
 - f) the products of Chapter 46 [which includes manufactures of straw, esparto or of other plaiting materials; basketware and wickerwork];
 - g) footwear and its component parts of Chapter 64;
 - h) articles in Chapter 66 (for example: umbrellas, canes and their parts);
 - ij)* the products of Heading 68.08
 - k) costume jewelry of Heading 71.17
 - l) The articles of Sections XVI or XVII (for example: machine parts, boxes, covers for machines and apparatuses and parts of cartmaking.)
 - m) The articles of Section XVIII (for example: boxes and similar packaging of jewelry making apparatuses and musical instruments and their parts.
 - n) gun parts (Heading 93.05)
 - o) the articles of Chapter 94 (for example: furniture and lighting fixtures, prefabricated construction materials.)
 - p) the articles in Chapter 95 (for example: toys, games, and items used in sports.)
 - q) the articles of Chapter 96 (for example: smoking pipes and their parts, buttons, pencils
 - r) the articles of Chapter 97 (for example: art objects)
2. In this Chapter densified wood is understood as wood, including plywood, that has received a chemical or physical treatment (for plywood, this must be more intense than)
3. In Headings 44.14 to 44.21, the articles of particle board or similar boards, fiber board, stratified wood or high density wood, are similar to the corresponding articles of wood.
4. The products in Headings 44.10, 44.11, or 44.12 can be worked in order to obtain admitted profiles in the wood of Heading 44.09, curved, undulated, perforated, cut, or obtained in a form distinct from a square or rectangle or work in some other way, provided that those workings do not give them the characteristics of articles in other Headings..

5. The Heading 44.17 does not cover tools whose blade, knife, surface or other functional part is made of some material mentioned in Note 1 of Chapter 82.
6. Notwithstanding that stated in Note 1 above and except for any procedure to the contrary, whatever any reference is made to "wood" in the text of the Heading of this Chapter this also applies to bamboo and other natural wood materials.
