Medicare still on table in Dean balanced-budget plan

Democratic presidential candidate Howard Dean said in a weekend campaign visit in Iowa that he favors balancing the federal budget in part by limiting growth of entitlement programs. His remarks prompted escalated criticism from rivals who accuse him of favoring cuts to Medicare.

"We're going to have to limit the growth of entitlement programs. We don't have to cut," the former governor of Vermont said during the taping of "Iowa Press" on Friday at Iowa Public Television.

Although Dean said he would shield Social Security if spending restrictions were required to balance the budget, he declined to say which entitlements he would consider, and refused to rule out looking at Medicare, the federal health insurance for senior citizens.

"We don't know what numbers are going to fall where," Dean said in an interview Saturday. "The only thing I can tell you is we'll balance the budget faster than any other candidate, and we will not make any cuts in any major programs."

Rival presidential candidates Rep. [REDACTED] and Sen. [REDACTED] say Dean is wrong not to take Medicare off the table.

"When you cut Medicare to balance the budget, you end up hurting the program, hurting beneficiaries, causing their costs to go up," [REDACTED] said by telephone before a campaign event in Cedar Rapids. "It doesn't work."

Dean's comments Saturday sharpened his rivals' criticism of his Medicare position, which until now has been centered on his past statements.

As chairman of the National Governors Association in 1995, Dean endorsed a Republican-led effort in Congress

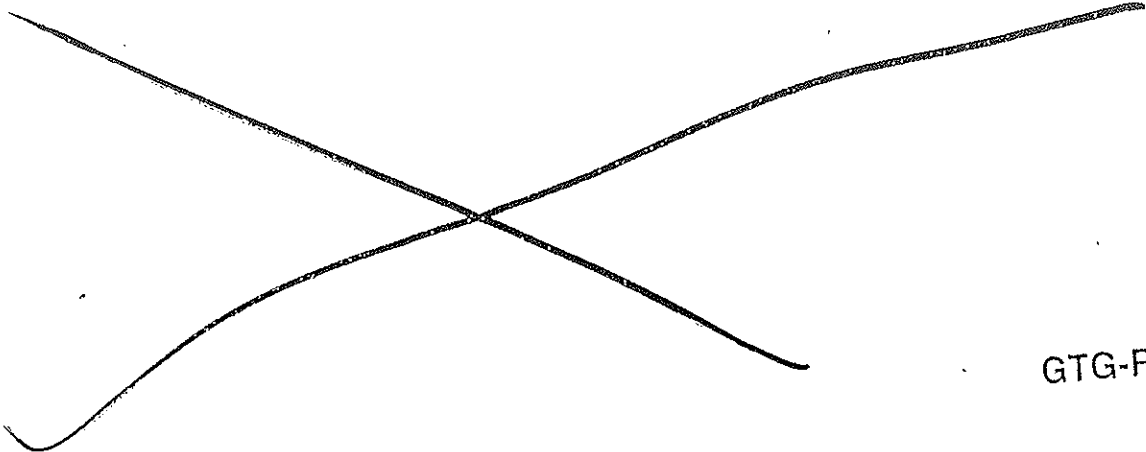

I need to ask a huge favor for this client. They were supposed to get funds to build a jail facility. Justice has screwed them around for years during Clinton (they didn't want jails I guess) and there are people at Justice (holdovers) who have made it very tough on them to get the funding. We were going to solve that with a hard earmark (meaning that the legislation - Commerce State Justice Appropriations - would have mandated the payment - \$16 million - and taken away DoJ discretion), but were only able to get a soft earmark. No one got a hard earmark for anything. Soft earmark means they have report language that the tribe should get funded, but it's not the same.

While we were successful in obtaining report language in the final version of the State Justice Commerce Appropriations bill that highlights the Choctaw jail, we need to begin a second phase of attack against the bureaucrats who have held up the project for so long. Late yesterday afternoon we had a great meeting with Karl Rove's office that will hopefully bear fruit shortly. Ken Mehlman, the Deputy Political Director at the Bush White House, promised to begin a campaign immediately to get Justice to release some of Fiscal Year 2001 money that still remains unspent from the Tribal Justice Fund at the State Department. However, to turn the screws even further, I suggest the following: 1. Thank [REDACTED] did try at the last minute to get the earmark through the House Appropriations Committee. He has delivered on the road projects we requested (although the final version of the legislation is not complete). We need to get him engaged in the effort to get the jail through Justice. If the Chief or Nell could call him and thank him for his efforts that would help get him further engaged in the effort. I also suggest that the Tribe mail the database of supporters asking them to call [REDACTED] and thanking them for what he is doing for the Choctaws. Then we go in for the ask.

2. [REDACTED] Letters, Meetings, Calls - We should immediately ask [REDACTED] to call both Ken Mehlman at the White House and David Israelite, the number two person at the Department of Justice to reiterate how important this project is for his re-election. We need to provide him with letters to send and also ask that he meet personally with Israelite and the bureaucrats in charge of the funding issue.

3. Letters from Leadership - I believe that we can quickly get letters from the House and Senate Leadership to the Justice Department demanding release of '01 funds. [REDACTED] has already indicated his approval for such a letter. This should ratchet up the pressure somewhat. Additionally, personal calls from [REDACTED] to Israelite will get this on his radar. Additionally, based on conversations with our associate Ron Platt, [REDACTED] will sign a letter to the bureaucrat in charge.

4. Move Staff Visits - I believe we should begin to bring key Congressional staff to the reservation, including the CJS Clerk who refused the earmark in the House. That will protect us, if God forbid, we need the earmark next year.

5. Another Round of Donations - Some of our supporters have really stepped up to the plate to help us. We should be prepared to give to their projects and causes as soon as the money is released.

While we were successful in obtaining report language in the final version of the State Justice Commerce Appropriations bill that highlights the Choctaw jail, we need to begin a second phase of attack against the bureaucrats who have held up the project for so long.

Late yesterday afternoon we had a great meeting with Karl Rove's office that will hopefully bear fruit shortly. Ken Mehlman, the Deputy Political Director at the Bush White House, promised to begin a campaign immediately to get Justice to release some of Fiscal Year 2001 money that still remains unspent from the Tribal Justice Fund at the State Department.

However, to turn the screws even further, I suggest the following:

1. [REDACTED] did try at the last minute to get the earmark through the House Appropriations Committee. He has delivered on the road projects we requested (although the final version of the legislation is not complete). We need to get him engaged in the effort to get the jail through Justice. If the Chief or Neil could call him and thank him for his efforts that would help get him further engaged in the effort. I also suggest that the Tribe mail the database of supporters asking them to call [REDACTED] and thanking them for what he is doing for the Choctaws. Then we go in for the ask.
2. [REDACTED] Letters, Meetings, Calls – We should immediately ask [REDACTED] to call both Ken Mehlman at the White House and David Israelite, the number two person at the Department of Justice to reiterate how important this project is for his re-election. We need to provide him with letters to send and also ask that me meet personally with Isrealite and the bureaucrats in charge of the funding issue.
3. Letters from Leadership – I believe that we can quickly get letters from the House and Senate Leadership to the Justice Department demanding release of '01 funds. [REDACTED] has already indicated his approval for such a letter. This should ratchet up the pressure somewhat. Additionally, personal calls from [REDACTED] to Isrealite will get this on his radar. Additionally, based on conversations with our associate Ron Platt, [REDACTED] will sign a letter to the bureaucrat in charge.

4. Move Staff Visits – I believe we should begin to bring key Congressional staff to the reservation, including the CJS Clerk who refused the earmark in the House. That will protect us, if God forbid, we need the earmark next year.
5. Another Round of Donations – Some of our supporters have really stepped up to the plate to help us. We should be prepared to give to their projects and causes as soon as the money is released.

Greenberg Traurig Saginaw Chippewa Work Summary (FY 03 & 04)

General

In 2002 and 2003, Greenberg Traurig's (the "Firm") central mission for the Saginaw Chippewa Tribe of Michigan ("the Tribe") was to increase the Tribe's presence and exposure among the nation's lawmakers and administrators in Washington, DC. Greenberg Traurig was tasked by the Saginaw Chippewa Tribal Council (at the direction of, and in coordination with, the Tribe's Legislative Affairs Department) to obtain Federal appropriations in several critical areas to fund diverse projects such as the construction of the Saginaw Chippewa Academy, the reconstruction of the Baseline Road, Saginaw Tribal Roads, Wind Energy Development Study, and the creation of the Joint Residential Treatment and Domestic Violence Center (Victims of Crime Program).

Greenberg Traurig has also been firmly committed to the protection and safety of the Tribal community. Our team responded decisively and effectively in 2002 (and hence forth) to a crisis involving drug-related criminal activities on the reservation. Greenberg Traurig came to the Tribe's aid during this time of need by activating the Department of Justice, which eventually led to the arrest of roughly thirty drug dealers from a nearby cocaine ring that were targeting the Tribal population. The Firm has used its contacts and influence at the Department of Justice to keep the lines of communication open in both directions.

Greenberg Traurig was responsible for initiating Federal challenges to counter recent proposals made by competing tribes in the area that not only threaten the Tribe's market share, but challenge the long-respected procedures for bringing land into trust and establishing a casino operation on tribal lands. Specifically, Greenberg Traurig was successful – and solely responsible – in defeating the Bay Mills land swap proposal for two consecutive years, and also managed to delay – with the intent of ultimately defeating – the Gun Lake Tribe's land in trust application to keep that tribe from going forward with its plans for a multi-million dollar casino in Allegan County, and the Senator Stevens "CIRI Amendment," which is described in greater detail below. Greenberg Traurig is also responsible for "holding" ██████████ Lumbec Recognition bill, S. 420, which if enacted would take away approximately 15% of Federal benefits from each tribe across the country because of the Lumbec's membership size. This matter is also discussed in more detail later on in this memo.

In addition, Greenberg Traurig worked on many legislative research projects for the Tribe to provide up to date legal analysis, accurate counsel, and powerful tribal lobbying. Greenberg Traurig also delivered advanced and factual information about the legislative schedule of the House and Senate. Lastly, Greenberg Traurig established a grant alert system for the Tribe to ensure the highest standard in meeting the Tribe's broad range of needs and interests at the Federal level.

II) Federal Appropriations

Greenberg Traurig was able to secure a number of significant appropriations for the Saginaw Chippewa Tribe during Fiscal Year 2003 and 2004 appropriations processes. It is important to note that the appropriations process typically ends in October of the previous fiscal year. However, due to the November 2002 election and the subsequent temporary change in power from Democrat to Republican control in the US Senate during the 2nd Session of the 107th Congress, the FY 2003 appropriations process was delayed until the new year. Work was finally completed on the massive, eleven-bill Omnibus Appropriations Act during the second week of February 2003. Another obstacle to passage was President Bush's insistence on a 2% across-the-board cut on all non-defense related appropriations. Despite these impediments, Greenberg Traurig was successful in its lobbying efforts to obtain several considerable appropriations for the Tribe.

Similarly, the Fiscal Year 2004 appropriations cycle has also delayed for several of the appropriations bills. Currently, 7 of the 13 appropriations bills have yet to pass, and are included in an Omnibus appropriations bill that is likely to pass in late January/early February of 2004.

Interior Appropriations

➤ School Cost Share – Tribal School Construction Demonstration Program

In FY 2003, an appropriation for three million dollars was included in the Interior portion of the Omnibus bill for a five-year demonstration program that would allow willing tribes to cost-share the construction of tribal schools (*Attachment 1*). Including this language in the Omnibus bill was controversial for two main reasons: (1) it was new and unauthorized spending; and (2) it would defy nearly two decades of BIA efforts to prohibit schools not on the BIA Replacement Priority List from receiving Federal construction dollars (the Saginaw Chippewa Academy is a non-BIA-operated school).

A tremendous amount of "ground work" needed to be laid before this project could come to fruition. Greenberg Traurig served as the driving force behind the production of six letters of support to various relevant House-Senate Chairmen/Ranking members. This included a letter from [REDACTED] waiving jurisdiction of the authorization language which prohibited the program from being subject to a point of order. [REDACTED]

[REDACTED] This proved to be a powerful clarification of the Tribe's role in bringing the Demonstration Program to the Senate's attention, and of the Tribe's ultimate responsibility for the program to receive funding (*Attachment 2*).

Through out the year in 2003 (FY 04 Appropriations), the Firm tried to free-up the money without additional legislative work by coordinating several letters to Secretary Norton asking her to release the appropriated money (*Attachment 3*). Unfortunately, the process dragged on too long and we were forced to insert a \$3 million "hard" earmark in the FY 04 Interior Appropriations bill that included a line item for the Saginaw Chippewa Indian Tribe (*Attachment 4*).

Transportation Appropriations

➤ Baseline Road – Isabella County, Michigan

In FY 03, Greenberg Traurig was successful in obtaining \$1,475,000 in Federal dollars for the Baseline Road, which services many of the rural districts in Nottawa, Deerfield, Union and Isabella townships in Isabella County, Michigan. The money will be used for re-paving, drainage upgrades and bridge replacement over roughly 9 miles. It is important to note that the Baseline Road project is the third highest dollar figure for transportation earmarks in the Omnibus appropriations bill for the entire state of Michigan (*Attachment 5*).

➤ Saginaw Tribal Roads (*on-reservation*)/Mt. Pleasant Municipal Airport

In FY 04, Greenberg Traurig was successful in obtaining \$1,200,000 in Federal dollars for the Saginaw tribal roads (*Attachment 6*). Previously, the Saginaw Chippewa tribe had been receiving roughly \$60,000 per year. The \$1,200,000 million appropriated to the tribe covers nearly half the outstanding inventory for all the tribal roads on their reservation lands.

Also in FY 04, the Greenberg Traurig was successful in obtaining \$150,000 for construction work at the Mt. Pleasant Municipal Airport. Like the Baseline Road, the Tribe submitted this request on behalf of the airport in an effort to build their relationship with the local non-Indian communities (*Attachment 7*).

Labor-HHS/CJS/VA-HUD Appropriations

➤ Victims of Crime – Joint Residential Treatment and Domestic Violence Center

In FY 03, Greenberg Traurig was able to secure \$405,000 from the VA-HUD/BDI section, \$1.1 million from the Labor-HHS/HRSA section and \$500,000 from the CJS/JJP section for a total of \$2,005,000. This amount will be used for the construction, equipment and operational costs associated with the Tribe's proposal to build a domestic violence and

residential treatment center. It is important to note that each account is dedicated for a certain purpose, i.e. construction, equipment, or operation. This is determined by the designated earmark (*Attachment 8*).

In FY 04, Greenberg Traurig was successful in obtaining an additional \$750,000 in the Labor-HHS appropriations for continued funding of construction and programmatic costs associated with the Victims of Crime Program (*Attachment 9*).

➤ **Saginaw Chippewa Tribal Police Force**

Also, in FY 04, Greenberg Traurig was successful in obtaining \$300,000 in the CJS appropriations bill for the Saginaw Chippewa Tribal Police Force (*Attachment 10*).

Agriculture Appropriations

➤ **Saginaw Chippewa Water Main Extension Program**

In FY 04, Greenberg Traurig was successful in Obtaining \$200,000 for the Saginaw Chippewa Water Main Extension Program (*Attachment 11*).

Energy and Water Appropriations

➤ **Saginaw Chippewa Wind-Energy Project**

In FY 04, Greenberg Traurig was successful in obtaining \$300,000 for the Saginaw Chippewa Wind-Energy Project (*Attachment 12*).

III) Protecting the Tribal Community

The Saginaw Chippewa Tribe has long faced a myriad of societal problems that mirror those found in mainstream culture, including crime, influence of gang

activity, alcohol abuse, and the illegal use of drugs. However, in 2002 and 2003, the Tribe witnessed an alarming increase in drug-related crimes on the reservation, and this dangerous trend quickly spiraled out of control. The level of danger reached critical levels in the summer of 2002, when a number of Tribal members were kidnapped by drug dealers of a Detroit crack cocaine ring, and held hostage until someone could come to "bail" them out. The drug dealers were allegedly targeting the local Native American population because of a misguided perception of the Tribe's bountiful and available wealth. In fact, the Detroit men had another goal – to father children with Tribal women – because they believed this would merit per capita income. Clearly, the Saginaw Tribe would not have been able to handle this crisis alone.

Greenberg Traurig's involvement proved to be essential in putting an end to the drug kidnapping emergency. We immediately activated our team to engage the Department of Justice in this pursuit – specifically Attorney General John Ashcroft, and Director of the Office of Tribal Justice, Tracy Toulou. We coordinated and drafted letters from [REDACTED] and [REDACTED] urging the Justice Department to respond decisively and effectively to the plight of the Saginaw Tribe.

The efforts of Greenberg Traurig created an umbrella effect with the District Attorneys in the State of Michigan. In turn, these D.A.'s pressed for immediate police involvement, and this led directly to the September 2002 arrests of approximately 30 drug dealers involved in the kidnappings.

Greenberg Traurig successfully rose to the occasion by putting forth its utmost effort to respond energetically and quickly to the time-sensitive needs of the Tribe. By galvanizing the support of the Department of Justice, our team managed not only to stop the criminals in their tracks, but also to draw Federal attention to the Saginaw Tribe. During the crisis, federal prosecutors visited the Tribe's reservation for the first time since the 1920's, thereby focusing national energy to the critical matter.

In 2003, Greenberg Traurig continued to help the Tribe plan and adopt programs to address the societal problems of the Tribal community. Although some success has been attained in the arena of drug-related criminal activities, many of these woes continue to fester, and will need additional attention. The Saginaw Chippewa Tribe has the vision, will, and determination to face and address these problems in a forthright and stalwart manner, and Greenberg Traurig will remain committed to this important pursuit.

IV.) TEA-21 Reauthorization

We worked on two major transportation issues for the Saginaw this year. First we framed a very large TEA-21 request for the Interstate US-127 project, a \$163 million construction project. Funding for this project was requested by [REDACTED]

[REDACTED] Greenberg Traurig drafted the formal House Transportation and Infrastructure request form and circulated it to the relevant members for their signature (*Attachment 13*). We educated staff and Members about the merits of the project and the need for the project to begin now, but to be phased over a few years due to the very large price tag. The project—along with thousands of others—could be considered early in 2004, if the House takes up the reauthorization bill as it is expected to do in Committee. (The Senate bill contained no projects, as has been the case during the last few reauthorizations.) There may be a delay in consideration of the bill until after the election in November 2004 because of a larger political fight over the wisdom of raising the gas tax to pay increase the funds in the Highway Trust Fund for road projects and transportation programs.

We also worked on a major new provision to incorporate into the TEA-21 highway bill. The provision will allow tribes to issue Tax-exempt bonds for tribal road projects and have the government pay back 75% to 90% of the value of the bonds. We are negotiating the language with the House authorizing committee now. The Senate authorizing committee bill contained no new programs because its bill authorizes much less funding, so the provision is not contained in that bill. This provision would put Tribes in control of issuing bonds for important road construction projects because they would generate the funding for the projects from the markets without waiting on the BIA.

Additionally, we have worked on reforms to the current Indian Reservation Road Program in the BIA. These reforms essentially shift the program from the BIA directly to Tribes to administer. It allows Tribes to take the overhead funds that the BIA now keeps and apply them to their own road program.

V.) Land Grant Status for Tribal College—Indian Technical Corrections

Greenberg Traurig included a provision in S. 532, the Native American Technical Corrections Act of 2003, that would have extended Land Grant Status to the Saginaw Chippewa Tribal College. The Saginaw provision was included in the base text of [REDACTED] bill that was introduced on March 5, 2003 (*Attachment 14*).

This provision passed the Senate Indian Affairs Committee, the full Senate, and the House Resources Committee by "Unanimous Consent". The Agriculture Committee has now objected to the provision because the American Indian Higher Education Consortium (AIHEC) sent a letter to [REDACTED] (R-VA) against the Saginaw's membership. It is important to note that AIHEC

sent the letter against the Saginaw even though the Tribe is a paying member of the organization. Greenberg Traurig had been successfully putting pressure on the Chairman and House Leadership to maintain the provision and "roll" AIHEC, but with the Firm off the field, will most-certainly get stripped from the bill. This provision would have brought the Saginaw Chippewa Tribe \$600-800,000 per year in programmatic funding for the tribal college.

VI) HUD

In October of 2003, the Deputy Assistant Secretary for Intergovernmental Affairs at the Department of Housing and Urban Development contacted Greenberg Traurig to discuss the possibility of the Secretary, or possibly the President of the United States, visiting Saginaw in the spring to highlight minority housing programs. HUD plans to do 5-7 events throughout the country next year highlighting such programs. The inquiry from HUD regarding the visit by the Secretary or the President is a direct result of Chris Petras and the Firm's networking efforts and friendships at HUD. Following our initial discussions with HUD representatives regarding the willingness of the Saginaw Chippewa to host such an event, we were informed that the Saginaw were included on the recommended master list of events sent to the White House for review. We should hear in early 2004, if the Secretary or President will visit Saginaw Chippewa reservation.

VII) Lumbee

The Lumbees of North Carolina continue to ignore established procedures in their attempt to gain federal recognition. The Lumbees may very well be entitled to federal recognition and the benefits that come with it. However, the Lumbees are not entitled to circumvent an established system requiring a detailed review of multiple criteria in order to gain federal recognition through an individual legislative measure. The Lumbees are no different than any other American Indian Tribe and they should be bound to follow the formal acknowledgement process administered by the U.S. Department of Interior which every other American Indian Tribe has had to follow.

For inexplicable reasons- perhaps to secure constituent support - [REDACTED] assisting the Lumbees in a manner that wholly disregards long-standing administrative procedures for federal recognition. There is no valid basis for doing this.

The Congressional Budget Office estimates the initial recognition of the Lumbee will cost approximately \$500,000,000. Without budget increases, this could impact Federal benefits to existing tribes by as much as 15 percent.

VIII.) CIRI

This amendment would authorize Alaska Native Regional Corporations to be treated as Indian Tribes for purposes of the Indian Gaming Regulatory Act and to take land into trust in the continental United States for gaming purposes. The amendment gives the Alaska Native Regional Corporations the right for ten years to have land automatically taken into trust for gaming purposes and to have that land treated as if had been in trust prior to the passage of the Indian Gaming Regulatory Act which would give the Corporation the right to conduct gaming without the State's consent. One of the Alaska Regional Native Corporations, Cook Inlet Region, Inc., has statutory authority to acquire federal land wherever located.

VIX.) Safeguarded Tribal Interests From Taxation

Worked continually with House and Senate Leadership, Ways & Means, Finance, Members of Congress and staff to prevent legislation, legislative language in tax bills and amendments/riders.

- Indian Gaming Tax
- Restrictions On Taking Lands Into Trust
- Motor Fuels/Cigarette Taxation

X.) Protected Tribal Interests On Appropriations Bills

Worked with House and Senate Leadership, Appropriations Committees, Members of Congress and staff to prevent amendments/riders adverse to client and Indian country in general.

XI.) Targeted Defense Of Indian Gaming

Continued our campaign with Members of Congress, staff, media, Indian tribes and organizations and DC policy and think tank groups to promote tribal gaming, economies and self-sufficiency. Launched targeted offensive against Indian gaming critics by articulating that Indian gaming revenues fund tribal governments, supplement and even supplant declining Federal tribal resources and have allowed tribes to develop tribal economies and diversify and expand tribal business.

- Fought Unnecessary Expansion of National Indian Gaming Commission Into Class III Gaming

- Fought IGRA Amendments (Campbell Legislation)
- Internet Gaming - Ensured That Tribes Receive Equal Treatment

XII.) Promote Tribal Economic Diversification And Private Sector Development

Continue work with Leadership, Members of Congress, staff, media, think tank and policy groups to educate the Congress and public about tribal governments and importance of developing tribal economies to provide services to tribal members.

- Passage Of Legislative Language That Assists Tribes With Economic Development And Diversification
- Creates Incentives For And Advocate Private Sector Development
- Encourage Economic Diversification On Reservations

XIII.) Tribal 401k/Pension Plan Legislation

H.R. 3605 was introduced by [REDACTED] on Friday, November 21. The bill would amend the Internal Revenue Code of 1986 and the Employee Retirement Income Security Act of 1974 to clarify that federally recognized Indian tribal governments are to be regulated under the same government employer rules and procedures that apply to Federal, State, and other local government employers with regard to the establishment and maintenance of employee benefit plans. This legislation is to provide a vehicle for obtaining cosponsors and gathering support in the House and Senate as we seek to attach the measure to the Pension Bill next year.

XIV.) Regional Gaming Matters

The Saginaw Chippewa Tribe is faced with a myriad of threats to their market share. While there are several non-tribal groups seeking additional gaming in the state (race tracks), the biggest threat to the Tribe is the ever-increasing efforts of neighboring tribes to obtain Class III gaming through the use of outside financiers and behind the scene political deals.

Tribal Threats:

Bay Mills Indian Community -- During the 107th Congress, the Bay Mills Indian Community, with much assistance from several political heavyweights in Michigan, was able to persuade [REDACTED] introduce land-swap legislation (S. 2986/H.R. 5459) that would place land into trust for the Bay Mills tribe for off-reservation gaming purposes. The legislation was hastily introduced at the end of the legislative session, and would

have been harmful for many reasons if it were allowed to pass. It was dangerous not only for its bad public policy and negative precedent-setting, but also for the sole fact that it would detrimentally impact the Saginaw Chippewa's market share.

(1) If passed, the legislation would have undermined the gaming compacts that were approved by the Michigan State Legislature after years of careful and deliberate negotiations.

- [REDACTED] would have circumvented the terms negotiated in all eleven Tribal-State Compacts, including the Compact to which Bay Mills is a party, which prohibits off-reservation gaming in the absence of a revenue-sharing agreement involving all of Michigan's federally recognized Tribes.

- In recent gaming compacts, the Tribes involved all agreed to limit themselves to one gaming site for each tribe. However, this legislation would allow Bay Mills, which already has two gaming facilities, to open an additional facility hundreds of miles from its own reservation, in direct competition with the Tribes of the lower peninsula.

(2) Allowing a tribe to settle a land claim and receive trust land hundreds of miles from their reservation for the express purpose of establishing a gaming facility sets a dangerous precedent.

- The pursuit of off-reservation gaming operations should continue to follow the procedures outlined in §20(b)(1)(A) of The Indian Gaming Regulatory Act (P.L. 100-497), authorizing Tribal gaming operations on off-reservation "after-acquired lands" where the land to be acquired has no relationship to the land upon which the claim was based.

- The proposed casino would be located just north of Detroit on a major link to Ontario

that is in the lower corner of the lower peninsula. Bay Mills is located in the upper peninsula.

(3) The legislation is fundamentally flawed because it allows Bay Mills to establish gaming facilities under the guise of settling a land claim.

- The land claim simply serves as an excuse for the Bay Mills tribe to take land into trust for off-reservation gaming.

Greenberg was successful in delaying the hearing on S. 2986 in the Senate Indian Affairs Committee (SIAC) for almost two weeks. This was important because the legislative session was nearing an end, and time was running out for Committee markup and floor consideration of the legislation. Although we were unable to block the hearing, we were ultimately successful in shedding light on the legislation's impact by directly lobbying SIAC members and staff.

██████████ tried bringing her legislation up by unanimous consent on the Senate floor. We were successful in obtaining an objection by ██████████ and thereby were able to defeat the proposal for the year.

Despite Greenberg Traurig's recent successes in the Bay Mills matter, the land swap proposal continues to pose an on-going threat. ██████████

██████████ in February of 2003 (H.R. 831) for the 108th Congress to consider.

Gun Lake.— The Gun Lake Tribe, otherwise known as the Match-E-Be-Nash-She-Wish Band of Pottawatomí Indians, was recognized by the federal government as a sovereign Indian nation on August 23, 1999. The Tribe is headquartered in Allegan County of western Michigan, in the town of Dorr, about 20 miles south of Grand Rapids. When it received its federal status, it had an enrollment of 127. David K. Sprague is the Chairman of the Tribe.

Currently, the Gun Lake Tribe wants to build a multimillion dollar casino resort in Wayland Township, near Dorr, which would include a hotel, three restaurants, a sports bar, two fast-food outlets, an entertainment lounge for live performances, and a 180,000 square foot casino. However, two steps remain before the casino can be built: (1) putting the proposed site into federal trust, and (2) obtaining a compact with the state of Michigan.

Working with Republican members of the Michigan delegation, Greenberg Traurig has successfully extended the public comment period for the Gun Lake Tribe's Environmental Assessment regarding their land in trust application. We have coordinated letters from the Michigan delegation to Secretary of Interior

Gale Norton, Governor Granholm of Michigan, and the BIA Regional Office in Minnesota opposing the Gun Lake Tribe's application from moving forward. We have also drafted talking points and technical questions, and have counseled "friendly" members of the Michigan delegation on this matter. We have met with politically relevant staff at the Department of Interior and have thoroughly explained the impact of such a casino on Western Michigan and on the Saginaw Chippewa Tribe, and have described to them the views of Republican Members of Congress in this region of the State.

Like Bay Mills, the Gun Lake situation is not going away. The Gun Lake Tribe has made public comments to the press that they will approach Governor Granholm in an effort to obtain a Class III gaming compact with the State of Michigan. Furthermore, due to the fact that the Environmental Assessment is still under review at BIA, a real threat remains that the Gun Lake Tribe could obtain land in trust within the next 18 months.

Pokagon Band – The Pokagon Band represents the most immediate threat to the Tribe's market share. They have a compact with the State of Michigan, and have all but satisfied each of the Federal requirements to place land in trust for its proposed casino. Strategically located in New Buffalo, Michigan, the Pokagon tribe is approximately 70 miles from Chicago – 300 miles closer than Mt. Pleasant. Pokagon is currently fighting a lawsuit that is now the only remaining obstacle left to prevent them from breaking ground on the new casino site. Once that roadblock is cleared, the tribe expects to complete construction and open its doors for business in less than a year.

The proposed Pokagon resort and casino will occupy 675 acres of land and cost approximately \$160 million to build. The tribe has partnered with Minnesota-based Lakes Gaming to build the 6,000-slot facility. The casino, as it is now planned, will become the fourth largest Indian casino in the Nation and will likely draw over 4 million gamblers a year and generate about \$250 million annually¹. It is clear that the facility will effectively place a clamp on the upstate flow of gamblers from Southwest Michigan and Chicago.

On May 9, 2002, U.S. District Court Judge James Robertson stated his concern that the Department of Interior rushed to approve casino plans for the Pokagon tribe without enough consideration of the casino's environmental impact. Judge Robertson did not issue a ruling, but did agree to hear arguments about whether further environmental studies are needed for the planned casino site in New Buffalo. The conflict arose after an opposition group, Taxpayers of Michigan Against Casinos, sued the Interior Department after it announced it would take land into trust for the Pokagon Band's planned casino. The Interior Department's

decision came on January 19, 2001, one day before the Bush Administration took office.

Judge Robertson questioned why the government did not wait for the Army Corps of Engineers to complete its report on the impact of wetlands in the area before finding that the 50-acre casino and resort would not significantly impact the environment. He also felt that the Interior Department should have waited for the State of Michigan to complete an assessment and issue a letter declaring there would be no effect on the environment. "The suggestion in the record is a rush to judgment.....Get it done. Never mind the no effect letter."²

On January 21, 2003, the Pokagon's claim for summary judgment was denied. Judge Robertson's order (Civil Action 01-0398) temporarily barred BIA from taking land into trust for Pokagon while the Environmental Assessment is "remanded for such further evaluation and elaboration" concerning secondary growth effects.

Throughout the court proceedings, Greenberg Traurig met with nearly every member of the Michigan delegation, the House and Senate Leadership, and the White House. Direct lobbying efforts centered on the overall impact of the Pokagon casino proposal, focusing specifically on environmental implications, as well as the deficient legal standing of the Pokagon compact given that it was granted via a State resolution rather than through enacting legislation. Greenberg Traurig also highlighted the political impact on Republican members of the House of Representatives if another tribal casino opens to the relevant political operatives within the Bush Administration, the Republican National Committee, the National Republican Congressional Committee, and the National Republican Senatorial Committee.
