Steve Parker, Lead Business Development Specialist of the Wyoming Small Business Administration, presented this prestigious award. Joe, Michael and E.J. were nominated by the Saratoga/Platte Valley Chamber of Commerce, Stacy Crimmins, Executive Director.

This award is given to individuals who own and operate or bear principal responsibility for operating a small business that demonstrates a substantiated history as an established business. Other evaluation criteria includes evidence of



success as measured by sales and profits, growth in number of employees, demonstrate potential necessary for long-term business success and economic growth, and voluntary efforts to strengthen family-owned businesses within the community.

The President of the United States recognizes contributions of the small business community to the American economy and society by proclamation each year.

Shively Hardware Company is a family owned business in its fourth generation. It began more than 80 years ago when Edward Shively bought the business, which is still located in the original building built in 1888 in downtown Saratoga. Edward's son-in-law, John Glode, succeeded him and John's two sons, Joe and Mike, took over the business in 1977. Joe's son E.J. joined in 1998 and a new implement dealership was built north of town in 2000. This 7aquestions address receives questions about all SBA 7(a) and also the RLA loan program, so you might clarify that your particular question has to do with a potential RLA loan application as opposed to a full 7(a) application.

Should you want to call for a brief conversation, you will be calling the SBA Western U.S. Loan Disaster Office and therefore the answering machine will say, "Welcome to the SBA Disaster Office" The SBA RLA and Regular 7(a) people share office space with the SBA Disaster Office and that is why the recording says SBA disaster office.

So, just wait for the message to conclude and then dial one of the two following extensions and you will get to the desk of a person that works with RLA loans.

By the way, there are two different SBA new loan processing centers in Sacramento, California. The regular SBA 7(a) and the RLA loans are processed at the SBA office in Citrus Heights (Sacramento). The Express and 504 Debentures are processed at the downtown SBA office in Sacramento.

Business must be at least 51 percent owned and controlled by a Black American, Native American, Hispanic American, Asian Pacific American, or Subcontinent Asian American.

Factors to be considered when making a nomination include: the firm must be in satisfactory financial condition, show a growth in total sales and a growth in net profit, growth in full-time employees or employment of the disadvantaged. A nominee should indicate their participation in community projects or charitable organizations. Consideration will also be given if the nominee has overcome obstacles or adversities in their business history or have a unique product or service.

SBA, in partnership with public and private sector small business supporters, will sponsor special activities honoring the nation's Minority Small Business Entrepreneurs during Minority Enterprise Development Week (MED Week) in September.
