EPA AWARDS \$2 MILLION IN ENVIRONMENTAL INFORMATION GRANTS

Acting Administrator Marianne Horinko today announced over \$2 million in environmental information grants to four states, the District of Columbia and two Native American tribes. This is the first phase of fiscal year 2003 funding for ongoing work on the National Environmental Information Exchange Network, which enables sharing of environmental data between EPA, states, tribes and other partners over the Internet. When completed, the Exchange Network will integrate state and federal environmental data, facilitate the reporting of data to EPA Headquarters by the states, and improve data quality.

"The Report on the Environment indicated areas where more data is required to make important environmental assessments," said Horinko. "One of the biggest obstacles to states and private companies reporting data to EPA is incompatible computer systems that do not allow the smooth transfer of data on-line. The grants announced today allow states and tribes to continue important work in resolving technology transfer issues, with the long-term goal of a national environmental management system that gives both EPA and all citizens the best environmental data possible."

The Exchange Network fosters the principles of the President's e-government initiative, which uses Internet technology to streamline reporting, improve the delivery of timely and reliable data to citizens and increase cooperation among federal, state, and tribal authorities.

The following states and tribes will receive grants this week:

- North Dakota Department of Health, Environmental Health Section, One Stop Grant of \$500,000
- District of Columbia Department of Health, One Stop Grant of \$500,000
- Delaware Department of Natural Resources & Environmental Control, Readiness Grant of \$297,700
- Kansas Department of Health and Environment, Readiness Grant of \$297,700
- Maryland Department of the Environment, Readiness Grant of \$297,700
- Cherokee Nation (Okla.), Challenge Grant of \$190,000
- Saint Regis Mohawk Tribe (N.Y.), Readiness Grant of \$100,000.

Environmental Information Exchange Network Grant

EPA's FY 2003 Appropriations Bill contained \$20 million for grants to be used in partnership with States, Tribes, and Territories to advance the Environmental Information Exchange Network (Exchange Network).

Purpose

The goal of the Exchange Network Grant Program is to advance the Exchange Network and to support State and other partners' data integration efforts. Funding will be provided through grants to States, Trust Territories, and Tribes to provide core capacity capabilities as well as to promote Exchange Network participation.

Background

By September 2003, EPA will distribute \$20 million for grants in the second year of the Exchange Network Grant

Program to 44 states, 18 tribes and two U.S. territories to work with EPA in developing the Exchange Network.

The grant guidance for FY 03 contained the following components:

• **Network One Stop Grants** - Grant funds will be dedicated to advance readiness to participate effectively in the Exchange Network. This last year of funding for One Stop grants will met EPA's commitment to provide funding for the One Stop Program.

These grants are open to States, Tribes, and Territories that have not previously received a One Stop Grant. Funds are intended to support the broader goals of the One Stop program which were to:

- Reduce the reporting burden on industry, States, and local governments;
- Foster multimedia (air, water, waste) and geographic approaches to problem solving;
- Provide the public with meaningful, real-time access to environmental data;
- Improve Stakeholder participation.
- *Network Readiness Grants* Grant funds will be dedicated to support specific capacity building for Network participation.

These grants are open to States, Tribes, and Territories and must clearly identify core capacity building functions they plan to undertake to participate in the Exchange Network.

• *Network Challenge Grants* - Grant funds will be provided, through a competitive process, for any group of States, Tribes, and Territories to work collaboratively to promote the development of Network-related components with a broad benefit to all Network participants.

These grants are open to States, Tribes, and Territories. Projects must advance the functionality of the Exchange Network through the immediate flow of higher quality environmental data; create a model that could be easily implemented, have broad applicability, and be readily transferable to a wide group of Exchange Network participants; achieve burden reduction in both reporting and accessing information; provide increased public access to environmental data; and involve collaboration throughout the project.

• *Network Administration Grants* - Provides funding to support technical and administrative functions of the Exchange Network for State, Tribes, and Territories.

Achievements

- One Stop Base line Visits Ongoing.
- Final FY 2003 Guidance published December 2002.
- For FY 2003, EPA received a total of 117 applications by March 18, 2003.

Available Funding:

Approximately \$15M was made available for Network One Stop and Network Readiness Grants. Approximately \$2M was made available for Network Challenge Grants. Approximately \$1M was made available for Network Administration Grants and approximately \$2M set-aside for Tribes. approximatel1.9M. established at \$2M.

• For FY 2003, EPA will award a total of 68 applications by September 30, 2003.

Future Actions

- An EPA/State meeting will take place September 4, 2003 to discuss potential changes to the FY 04 guidance.
- EPA will revise the guidance for FY 04 and plans to publish in December 2003 Federal Register.
