DTV Consumer Education Quarterly Activity Report

Instructions

This form should be used to provide the Federal Communications Commission (FCC) with information pertaining to all station activity to educate consumers on the transition to digital television (DTV). All stations should log DTV Transition-Related Public Service Announcements (PSAs) and other DTV activities using the appropriate house (identification) numbers. These logs or records should include the date and time that each DTV activity occurred. This form must be filed in Docket Number 07-148 as Document Type: REPORT, and placed in the station's Public Inspection File. This form must continue to be filed for each quarter in which a station has DTV Transition education obligations.

On its analog channel, and its primary digital stream, a station must air one transition PSA, and run one transition crawl, in every quarter of every day. This requirement will increase to two PSAs and crawls per quarter per day on April 1, 2008, and to three of each on October 1, 2008. Stations are required to air PSAs or crawls at various times in any given day part, and at least one PSA and one crawl per day must be run during primetime hours. On-air education must not contain inaccurate or misleading statements and must be provided in the same language as a majority of the programming carried by the station. PSAs must be at least 15 seconds, and closed-captioned. Crawls must run during programming for no fewer than 60 consecutive seconds across the bottom or top of the viewing area (See rules for additional details).

KSAT launched an on-air segment titled "Answers to Questions You Didn't Even Know You Were Supposed to Ask" in 2001. The segments continue to air today, every Thursday morning during Good Morning America and are sponsored by a local electronics retailer. We've also aired several news stories about the DTV Road Show, which came through San Antonio in November 2007. We aired several additional news stories centering on topics such as the digital converter box coupon program, the recycling of television sets, and the testing of different types of digital antennas. These news packages aired in all of our local newscast from 5:00AM to 10PM, and were repeated on weekend newscasts.

KSAT launched www.ksatdigital.com in November 2007. The site provides all links to government sites promoting the digital switch. The site is linked to our main website, www.ksat.com, through a "Countdown to Digital" clock which was placed on our home page. The clock counts down the days, hours, minutes and seconds until February 18, 2009. Links on the digital site include www.dtvanswers.com and links to the FCC, NAB, Coupon Program, DTV Transition Coalition, and the Consumer Electronics Retail Association. . We are in the process of producing a video/DVD in which one of our meteorologists will explain and demonstrate how the coverter box works, how to obtain coupons, as well as help people to understand who's going to be affected by the switch. This video will be posted on our site. To date, we've had over 64,000 "page views" on our digital website, generating nearly six million "hits." The site gives users the option to select which method they use to watch television, then directs them as to what action they should take depending upon their method of receiving our signal.
