FEDERAL PANELS

LCvR16.3 Supp. § 2.4 Compensation.

(a) **In General.** Unless otherwise established by statute, prescribed by the Judicial Conference of the United States, directed by the Court or unless proceeding pro bono, mediators and evaluators may charge reasonable fees. The cost of the panel member's

services shall be shared equally by all the parties, unless otherwise agreed by counsel, and be payable at the time of the particular dispute resolution session. Fee schedules are set forth in the Court's roster books in the office of the Court Clerk.

(c) **Pro bono Service.** Each panel member must serve <u>pro bono</u> at least once per year if requested by the parties in an appropriate case or if requested or ordered by the Court. Members may do other <u>pro bono</u> service as appropriate.

G.O. 00-2 § F. Compensation.

- 1. ... The Court encourages full disclosure between neutrals and parties of all fee and expense requirements, limitations and arrangements prior to the commencement of the session.
- 3. ... The Court is mindful of the need for pro bono services in some cases, would encourage the discussion of reduced fees in appropriate cases and authorizes such discourse between counsel.
