INSTRUCTION FOR PREPARATION

Item 7 - Current financial information will be provided except if the box labeled "See'C' " is checked. Check one of the four boxes. A commercial credit report may be obtained in accordance with RD Instruction 1910-C. An OI report that provides the same information as in Items "7A" and "7B" may be used.

Item 7C - If the box labeled :see 'C' is checked, then one of the boxes in 7C must also be checked. A separate sheet should then be attached to the form setting out the details, if any are known, about: (1) the surety bond (for example, the bonding company's name or the reason why the County Supervisor believes the bond will cover this matter); or (2) the bankruptcy or receivership (for example, the date on which, and the place at which, it occurred); or (3) the insurance coverage (for example, the name of the insurer or the approximate amount, and the scope, of the coverage). The above example of the details requested for item 7C are merely suggestions of things to look for and are not meant to be required in every case or to be the only details which should be supplied.
