On: JUNE 1 TEXAS CATTLE ON FEED UP 2 PERCENT FROM LAST YEAR

AUSTIN . . . Cattle and calves on feed for slaughter market in Texas feedlots with capacity of 1,000 head or more totaled 2.96 million head on June 1, up 2 percent from a year ago. According to the monthly report released by the Texas Field Office, the estimate was also up 2 percent from the May 1 level. Producers placed 590,000 head in commercial feedlots during May, down 21 percent from a year ago, but up 30 percent from the April 2006 total.

Texas commercial feeders marketed 520,000 head during May, up 8 percent from last year and up 11 percent from last month.

On June 1, there were 2.49 million head of cattle and calves on feed in the Northern High Plains, 84 percent of the state's total. The number on feed across the area was up 4 percent from last year, and up 2 percent from the May total.

May placements in the Northern High Plains totaled 494,000 head, up 31 percent from the April total. Marketings were up 12 percent from last month to 435,000 head.

Cattle and calves on feed for slaughter market in the United States in feedlots with a capacity of 1,000 head or more totaled 11.2 million head on June 1, 2006. This inventory was 4 percent above June 1, 2005.

Placements in feedlots during May totaled 1.91 million head, 14 percent below May 2005. May placements of cattle and calves weighing less than 600 pounds totaled 440,000 head; 600-699 pounds totaled 370,000 head; 700-799 pounds totaled 503,000 head; 800 pounds and greater totaled 600,000 head. Marketings of fed cattle during May totaled 2.17 million head, 9 percent above 2005.
