

**Notice and Invitation for Biological Assessment Workshops

Phoenix Workshops: October 1-3 or 3-5, 2007 (two classes to choose from)

Albuquerque Workshops: April 7-9 or 9-11, 2008 (two more to choose)

Purpose:

To provide instruction and tools needed to prepare biological assessments, biological evaluations, and similar documents that initiate Endangered Species Act section 7 consultation with the Fish and Wildlife Service.

Determine the "action area"

Identify direct and indirect effects

Use sound science to reach appropriate effects determinations

Use early and close coordination to facilitate interagency consultation

Shorten consultation time by providing adequate information

Support ecosystem conservation with the biological assessment process

Organizers and Sponsors:

This course is being offered jointly by the Fish and Wildlife Service's National Conservation Training Center and the Southwest Strategy, and will be presented by Southwest Endangered Species Act Team (SWESA) members.

Who should attend:

Federal, State, and Tribal biologists and managers, private contractors, and others who prepare biological assessments, evaluations and similar documents. Seating is limited to 30 participants per workshop session. Each agency may be asked to limit their participation, if necessary, in order to allow for wider agency representation. The number of seats per agency may be flexible. If an agency does not need all the seats allotted to it, the vacant seats may be made available to someone else.

Course length: 16 hours over 3 days

Registration and Fees: There is no fee for this workshop. The registration form is attached and may be submitted by email (preferred), mail, or legible fax.

Lodging and Travel: Participants are responsible for making their own travel and lodging arrangements. Some nearby accommodations are listed at the Internet address provided for the Arizona workshops, and some are listed below for the New Mexico workshops.

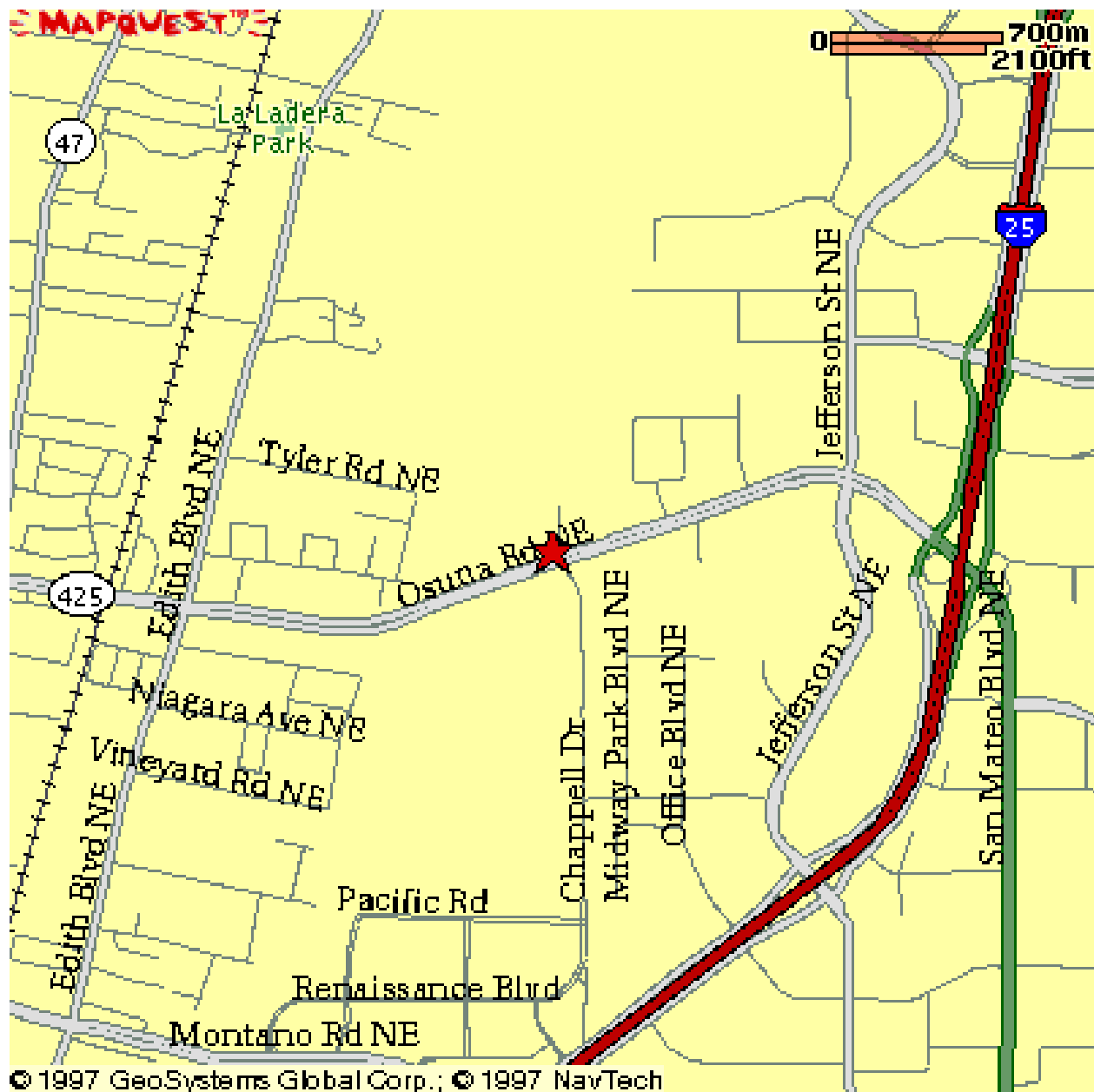
