T.R.I. TESTING

TRI Air Sample kits were sent out to all units with NOAA air compressors last month and this month.

Those units with compressors need to do the testing ASAP and get the kit back to TRI.

If you anticipate not being able to do the test immediately and need an extension you may call TRI directly and let them know you will be holding onto the kit for another week or two or make some arrangement with them.

If you anticipate not being able to do the test for over a month or so then you will need to send the kit back to TRI and contact the dive office to put your unit on hold until further notice and T.R.I. will not send kits until the compressor is up and running again.

NDSB BULLETIN RE: USCG HEALY

The NOAA Diving Safety Board conducted its annual meeting this week at the Nancy Foster Complex in Key West, FL. A special session was held to discuss the recently released report by the USCG on the USCGC HEALY diving incident, which occurred last August in the Arctic Sea and resulted in the tragic death of two USCG divers. The goal in reviewing the report was to identify any issues that might lead to a similar occurrence within the NOAA Diving Program.

The members of the Board felt that the risk of a similar accident at NOAA was minimal. However, to address concerns regarding the unique conditions involved in the USCG incident, the Board decided that augmenting our program guidance to create a more complete set of standards for specialty diving would be prudent.

The NDC will begin developing standards immediately for operations involving ice and/or cold water (<37° F) diving, linetended diving, overhead obstruction diving, and over-bottom (aka "blue-water") diving. In the interim, the Board will require that any of these specialty diving operations be pre-approved by the NDSB.

A full list of recommendations was formulated and sent to the Director, NMAO, and all divers, on February 27th, 2007

TO ALL NOAA DIVERS

The NOAA Diving Program is in the process of developing written standards for special diving operations including: ice and/or cold water diving, line-tended diving, overhead environments and over-bottom or "blue-water" diving. Until these standards are written, anyone desiring to perform such activities must complete a 1-page, fillable dive planning form and fax or email it to Steve Urick for review and approval.
