Rural households in China have traditionally consumed food

mostly grown on their own farms. While they continue to rely on self-produced grains, vegetables, meats, and eggs for a large portion of their diet, rural households are now purchasing more of their food as they enter the mainstream of the Chinese economy. Cash purchases of food by rural Chinese households increased 7.4 percent per year from 1994 to 2003. Consumption has shifted from self-produced to purchased food at a rate faster than can be explained by income growth or changes in other household characteristics. The move away from self-produced food is associated with lower consumption of staple grains, the most important selfproduced food in rural Chinese diets. Food consumed away from home is one of fastest growing categories of rural household the expenditures, doubling in budget share from 1995 to 2001. Commercialization of food consumption is diversifying Chinese diets. broadening food markets, and creating new opportunities for retailers and product distributors.

Just over a few decades ago, data on U.S. industries were mainly focused on agriculture and manufacturing; thus, comprehensive data on small business were not available. Tremendous efforts were undertaken by individuals and organizations to obtain the extremely valuable data by firm size that are taken for granted today. Documentation was needed to chronicle the creation of these data sources so that users could understand the strengths and weaknesses of the data and so that later efforts to produce new data sources could benefit from the previous experience. With the emergence of various longitudinal data sources for firms, studies on business size distributions, business turnover, and business growth/decline have had a resurgence among the academic community. The parking system at Boston-Logan International Airport may seem unglamorous to the average traveler, but for The Massachusetts Port Authority, its importance cannot be understated. Not only does the system provide a necessary service to great numbers of travelers every year, but also it generates income for MassPort that subsidizes many of its other activities. Using Accenture's Public Sector Value Model, we analyzed the public value creation of Logan's Terminal B Parking Garage. We created three outcomes consisting of three metrics each in order to conduct our analysis. Then, we used those outcome scores as the Y-axis and cost effectiveness as the X-axis in order to plot the results on a 2 X 2 matrix depicting public value creation. The garage services about one million customers per year and generates roughly 20 million dollars annually. However, four of the last five years have not produced the type of value creation necessary for the garage. While the events of 9/11 clearly had a negative effect, as they did on all airports, the biggest concern for this garage is its reaching of full

operational capacity. Our analysis showed that the garage has overextended its operational capacity. Because it has reached capacity, the garage's management can no longer realistically hope to significantly increase outcomes, and as costs inherently rise over time, lower and lower PSV scores will result. Each week brings more and longer closures, a larger parking gap, more revenue lost to damages, and lower customer satisfaction, while exits do not increase. Management will be unable to compensate for the higher costs because they will have few options by which to increase revenue. Since exits cannot increase, the only way to increase revenue is through an increase in rates, which is neither easy to implement or satisfactory to customers.

Congress authorized the creation of risk retention groups (RRG) to increase the availability and affordability of commercial liability insurance. An RRG is a group of similar businesses that creates its own insurance company to self-insure its risks. Through the Liability Risk Retention Act (LRRA), Congress partly preempted state insurance law to

create a single-state regulatory framework for RRGs, although RRGs are multistate insurers. Created as a bureau of the Treasury Department by the National Currency Act of February 25, 1863, the Office of the Comptroller of the Currency (OCC) was charged with the responsibility of organizing and administering a system of nationally chartered banks and a uniform national currency. In June 1864, the legislation underwent substantial amendment and became known as the National Bank Act. It remains the basic statute governing the national banking system today. FY 2003 was a year of growth and success for the national banking system. Continued record earnings were used in part to strengthen bank capital, which was already at record levels. Most major income categories hit historical peaks. Deposits increased, too, as consumers reacted to the weak performance of equity markets by placing funds in the banking system. This increase in deposits, in turn, fueled continued growth in bank assets. Macroeconomic weaknesses did create some credit quality issues for national banks, particularly in the corporate lending area. But with the rise in corporate earnings, the worst part of the credit quality now appears to be behind us, and asset quality for national banks saw significant improvement last year. Overall, the national banking system today is safe, sound, and competitive-and the outlook is for further improvement as the economic picture brightens, as most analysts forecast.

At the request of the Senate Committee on Appropriations, the Congressional Budget Office (CBO) has analyzed the Presidents budget request for fiscal year 2006 using its own economic assumptions and estimating techniques, with contributions from the Joint Committee on Taxation (JCT). This report presents CBOs analysis of that budget, which provides more details than the preliminary report released on March 4, 2005. According to CBOs estimates, carrying out the proposals in the Presidents budget would result in a deficit of \$394 billion in 2005, equal to 3.2 percent of the nations gross domestic product (GDP). That deficit would be smaller than the one recorded in 2004, which totaled \$412 billion, or 3.6 percent of GDP. The estimate for 2005 includes outlays of \$32 billion resulting from the Presidents recent request for supplemental appropriations, mainly for military activities in Iraq. In 2006, the deficit under the Presidents budgetary proposals would shrink to \$332 billion. CBO estimates but the Presidents request for that year omits additional funds to continue U.S. operations in Iraq and Afghanistan. Consequently, CBOs estimate of the budgets effects in 2006 reflects only outlays for those operations that would result from the 2005 supplemental request (a total of \$82 billion in budget authority) and from appropriations enacted for previous years. Additional funding to keep the operations at roughly the same level as expected for 2005 would add about \$40 billion to the 2006 deficit, bringing it to between \$370 billion and \$375 billion, or 2.9 percent of

GDP.

People, over time, generally experience changes in income and economic well-being. Nicaragua is a transshipment and staging area for shipments of cocaine hydrochloride (HCI) and Colombian heroin to North America. Local, national, and international law enforcement agencies increasingly are concerned about the transshipment of cocaine, heroin, marijuana, and methamphetamine through the Pacific Islands Region. Russia's Siberian Federal District (Siberia) and the Far Eastern Federal District (the Russian Far East, or RFE) have experienced a surge in heroin trafficking and abuse over the past several years. The reasons for the increase are complex, but the combination of increased Afghan heroin production, increased trafficking via the Silk Road in Central Asia, weak border controls, and a diminished Russian economy has fueled traffic into areas of Russia that had never experienced heroin on such a large scale. According to Antonio Maria Costa, Executive Director, United Nations (U.N.) Office of Drugs and Crime, only 1 percent of Russian drug abusers used heroin in 1996; today, nearly 30 percent of drug users abuse heroin. Only Laos, Tajikistan, and Iran have higher opiate-abuse rates. The economic and social impact of heroin abuse and trafficking in Russia are substantial. Russian officials estimate that half of the heroin transiting Russia is intended for European markets, while the remainder is targeted for domestic use in Russia. Although the impact of this heroin trafficking in Siberia and the RFE on the United States is less dramatic, the potential for harm is great because Russia's Pacific seaports are controlled by powerful organized crime groups. As Central Asian traffickers establish themselves more in eastern Russia, the opportunity exists to collude with Russian crime bosses to export heroin to the more lucrative markets of the Pacific Rim and the United States.
