# **Housing Available Through USDA Rural Development**

USDA Rural Development's *Multi-Family Housing Program (MFH)* provides clean and safe housing located in rural areas. Individuals/families displaced by the Southeast Kansas floods are eligible to be placed in available housing.

As an individual/family made homeless by this disaster, you may apply for occupancy as a "DISPLACED TENANT" and receive priority admission to any apartment complex financed by USDA. You will be placed on a special priority list to be offered a vacant apartment.

For residents already receiving USDA rental assistance (RA) in apartments made uninhabitable by the flooding, the Agency can allow the transfer of the RA to another eligible apartment complex under some conditions.

Attached is a listing of USDA *MFH* apartment complexes located in this region of Kansas. Many of these complexes have vacant apartments available for immediate occupancy. Please feel free to contact any of the complexes listed to inquire about available apartments.

USDA Rural Development is committed to providing suitable housing for persons displaced by these floods. # USDA RENTAL HOUSING ASSISTANCE PROGRAM

# **BACKGROUND:**

USDA Rural Development will help in providing rental housing in rural areas and support assistance to those individuals/families affected by the recent flooding.

# **ELIGIBLE PARTICIPANTS:**

- A. USDA Rural Development tenants or homeowners
- B. Other affected tenants or homeowners
- C. Anyone else who needs housing

In addition to being in one of these three categories, households must have a current FEMA number. A household may also have a Letter of Priority Entitlement (LOPE).

# **HOW THE PROGRAM WORKS:**

USDA Rural Development assists Agency-financed housing project management in completing an application and obtaining information required for the household to select a location in which to live. Project management will assist the tenant with utility hookups and will either waive security deposits or pay deposits for the household. Project management should complete a criminal background check of the prospective tenant.

USDA Rural Development is also working with the American Red Cross and other disaster relief organizations for assistance with transportation, food, clothing, health & beauty aids, along with assisting households with other programs including utility deposits.

The MFH rental lease will be month-to-month. Rents will be at basic rent; however, rental assistance, including utilities, may be provided for those eligible.
