**REPORT AND ORDER
(Proceedings Terminated)**

Adopted: March 12, 2003

By the Assistant Chief, Audio Division:

1. The Audio Division has before it *Notices of Proposed Rule Making*, specified below, setting forth twelve separate proposals to allot an FM channel to a specific community. Each petitioner filed comments in support of its proposal reaffirming its intention to apply for the specified channel, if allotted. Each proposal complies with all Commission technical requirements and we continue to believe that each proposal would serve the public interest. Accordingly, we adopt each proposal as originally proposed. These are as follows:

A. MM Docket No. 01-181; RM-10201

Action: At the request of Katherine Pyeatt, we are allotting Channel 298A at Wapanucka, Oklahoma, as the community's first local aural transmission service.¹

Coordinates: The reference coordinates for Channel 298A at Wapanucka are 34-21-54 NL and 96-23-47 West Longitude.

Additional Information: This allotment requires a site restriction of 2.9 km (1.8 miles) west of Wapanucka at the coordinates indicated above.

B. MM Docket No. 01-188; RM-10203

Action: At the request of Charles Crawford, we are allotting Channel 243A at Evant, Texas, as the community's first local aural transmission service.²

Coordinates: The reference coordinates for Channel 243A at Evant are 31-28-56 NL and 98-09-19 West Longitude.

Additional Information: This allotment requires a site restriction of 0.8 km (0.5 miles) north of Wapanucka at the coordinates indicated above.

community's second local FM transmission service.³

Coordinates: The reference coordinates for Channel 280A at Comanche are 31-53-50 NL and 98-36-12 West Longitude.

Additional Information: This allotment does not require a site restriction at the center city coordinates indicated above.

D. MM Docket No. 01-217; RM-10236

Action: At the request of Jeraldine Anderson, we are allotting Channel 274C2 at Hollis, Oklahoma, as the community's second local FM transmission service.⁴

Coordinates: The reference coordinates for Channel 274C at Hollis are 34-32-55 NL and 99-56-12 West Longitude.

Additional Information: This allotment requires a site restriction of 15.7 km (9.7 miles) south of Hollis at the coordinates indicated above.

Action: At the request of Jeraldine Anderson, we are allotting Channel 282A at Santa Anna, Texas, as the community's second local FM transmission service.⁵

Coordinates: The reference coordinates for Channel 282A at Santa Anna are 31-40-36 NL and 99-16-25 West Longitude.

Additional Information: This allotment requires a site restriction of 8.5 km (5.3 miles) north of Santa Anna at the coordinates indicated above. The Mexican government has concurred in this allotment.

Action: At the request of Katherine Pyeatt, we are allotting Channel 300C2 at Mooreland, Oklahoma, as the community's second local FM transmission service.⁶

Coordinates: The reference coordinates for Channel 300C2 at Mooreland are 36-27-59 NL and 99-14-27 West Longitude.

Additional Information: This allotment requires a site restriction of 4.4 km (2.8 miles) northwest of Mooreland at the coordinates indicated above.

Action: At the request of Jeraldine Anderson, we are allotting Channel 284A at Junction, Texas, as the community's fourth local FM transmission service.⁷

Coordinates: The reference coordinates for Channel 284A at Junction are 30-28-19 NL and 99-45-47 West Longitude.

Additional Information: This allotment requires a site restriction of 2.1 km (1.3 miles) southeast of Junction at the coordinates indicated above.

Action: At the request of Charles Crawford, we are allotting Channel 290A at Alton, Missouri, as the community's first local aural transmission service.⁸

Coordinates: The reference coordinates for Channel 290A at Alton are 36-44-39 NL and 91-24-28 West Longitude.

Additional Information: This allotment requires a site restriction of 5.6 km (3.5 miles) north of Alton at the coordinates indicated above.

Action: At the request of Linda Crawford, we are allotting Channel 228A at Taos, New Mexico, as the community's fifth local FM transmission service.⁹

Coordinates: The reference coordinates for Channel 228A at Taos are 36-28-20 NL and 105-28-22 West Longitude.

Additional Information: This allotment requires a site restriction of 11.5 km (7.1 miles) northeast of Taos at the coordinates indicated above.

Action: At the request of Linda Crawford, we are allotting Channel 233C3 at McCamey, Texas, as the community's second local FM transmission service.¹⁰

Additional Information: This allotment requires a site restriction of 19.9 km (12.4 miles) east of McCamey at the coordinates indicated above. The Mexican government has concurred in this allotment.
