This report alerts U.S. firms to **US\$ 309.9 million** in new technical assistance projects under the grant programs being administered by the Asian Development Bank for which consulting services may or may not be required. Opportunities are reported for Indonesia, Kyrgyz Republic and Vietnam. For 2004, U.S. firms, including many small consulting firms, succeeded in winning US\$33.13 million ADB-funded national technical assistance contracts out of a total ADB-financed consulting budget of US\$297.16 million.

The ADB selects a consultant for a TA grant based on its prior Expression of Interest (EOI). For some of these projects, the ADB may opt to use the method of Direct Selection in the hiring of consultants. An EOI can be transmitted on-line through the ADB's website (www.adb.org); afterward it will be acknowledged automatically. Firms may opt to send a hardcopy follow-up EOI addressed to Mr. Robert J. Robertson, Director, Consulting Services Division, with a copy to the ADB Project Officer. The EOI should relate a firm's experience and expertise to the ADB project. It is important for a U.S. firm to emphasize its similar project experience in the country, or in a similar geographic area, rather than present a general profile of its consulting activities. A separate EOI should be submitted for each project. The project name indicated in the EOI should exactly match that listed in the ADB Business Opportunities publication to avoid confusion.

To be considered for employment, consulting firms must register on the ADB's DACON (Data on Consulting Firms) system, or for individual consultants on the DICON (Data on Individual Consultants) system. Otherwise, their EOIs will not be accepted. DACON and DICON registration can be done on-line at www.adb.org/consulting.

ADB's DACON (http://www.adb.org/Consulting/dacon.asp) is a database of firms and other organizations from the ADB's member countries that are qualified to provide consulting services for ADB projects. The DACON contains information on the experience and capacity of the firms and organizations. ADB requires firms or organizations to register on the DACON so that the ADB can consider them for short-listing for a technical assistance project. The term "firm or organization" covers all sources of consultants, such as consulting firms, government agencies, public sector organizations, national and international institutions and non-government organizations.

The DICON (http://www.adb.org/Consulting/dicon.asp) system contains the names of persons who are citizens of ADB's member countries; are at the forefront of their respective fields; and may be practicing consultants or employees, whose organizations are prepared to release them for short periods to serve ADB; or retired persons with special experience who are still active.

Objectives and Scope:

The overall goal of the Earthquake and Tsunami Emergency Support Project (ETESP) is to help rebuild the affected regions and support their economic revival to meet the Millennium Development Goals (MDGs). The immediate purpose of ETESP will be to provide Disaster Management Rehabilitation and Reconstruction support to: (i) facilitate economic revival in the affected regions, through restoration of livelihoods; (ii) restore essential public services and rebuild infrastructure, with the aim of alleviating constraints faced by the lack of adequate public goods and facilities.

It has five principal components: (i) Livelihood Restoration- rehabilitate agriculture and fisheries sectors, the main livelihood of majority of the Acehenese, and revive micro and small enterprises (MSMEs); (ii) Social Services Provision- rehabilitate and reconstruct health and education facilities, and support skills development of the affected population through vocational training; (iii) Community Infrastructure- provide water and sanitation facilities, rebuild irrigation infrastructure, and rehabilitate and reconstruct the damaged and lost housing stock within an integrated community development framework; (iv) Physical Infrastructure- rebuild the damaged roads and bridges, restore electricity, support sound spatial planning and strengthen environmental management systems; and (v) Fiduciary Governance- ensure sound oversight on utilization of donor funds in the DMRR process, and facilitate effective delivery of ETESP support.

Objectives and Scope:

The impact of the Project will be the improvement of the general education system, which is responsive to the needs of a modern market-oriented economy and focused on poorer areas. The outcome of the Project is increased enrollment in primary and general secondary education in poorer areas of the country, and student performance raised through (i) improving the curriculum and learning assessment systems, (ii) strengthening the teaching profession, and (iii) upgrading facilities and equipment.

The Japan Fund for Poverty Reduction (JFPR) Project will contribute to poverty reduction in the mountainous districts in the northern central region of Viet Nam by enhancing agricultural income and ensuring food security (rice and maize) among the poor through community-based agricultural extension and training programs. The Project specifically aims to (i) improve livelihoods of the rural poor in remote communities through better cultivation practices on food crops, and through appropriate knowledge and technologies for other crops and income-generating activities; (ii) increase the capacity of local agricultural extension workers and grass root-level extension agents in appropriate cultivation techniques, and participatory and pro-poor extension services; (iii) establish farmer-to-farmer learning networks; and (iv) promote decentralized and participatory planning, monitoring and evaluation.
