Immediately register with FEMA for housing assistance. Some disaster assistance is contingent on your registration with FEMA.

You may:

- Register online
- Toll-free number: 1 (800) 621-FEMA (3362)  
(TTY: 800-462-7585) available 24 hours a day, 7 days a week.

FEMA's Individual and Households Program (IHP) provides an initial three month rental assistance payment in the form of check or electronic fund transfer in the amount of \$2,358. See FEMA's website ([www.fema.gov](http://www.fema.gov)) for details.

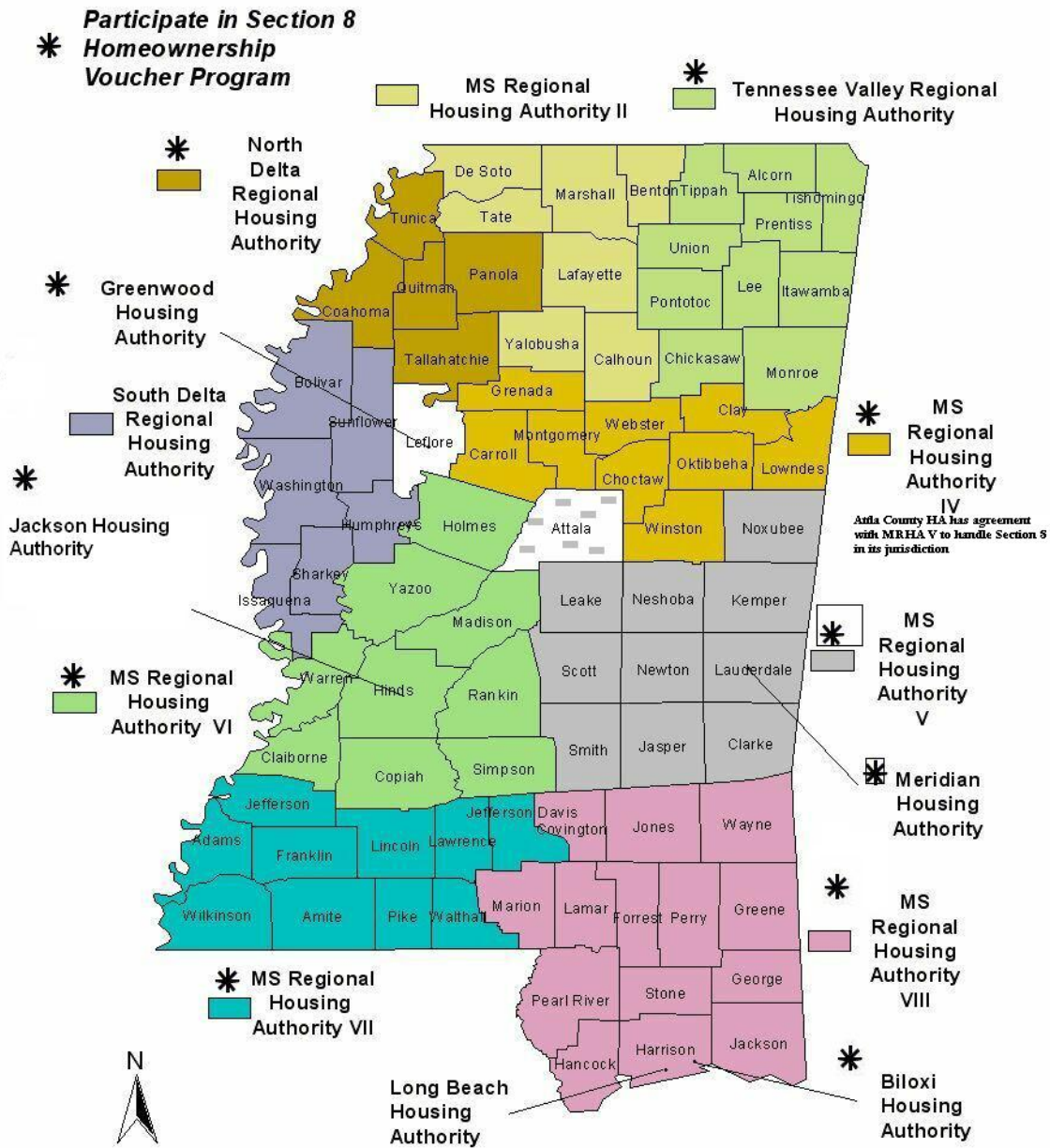

## **Mortgage Insurance for Disaster Victims**

When the President declares a disaster, certain mortgage origination and mortgage servicing actions are triggered and mortgage lenders should refer to HUD Handbooks 4155.1 REV-5, Mortgage Credit Analysis for Mortgage Insurance, and 4330.1 REV-5, Administration of Insured Home Mortgages, for further guidance.

HUD has a special mortgage insurance program under **Section 203(h)** of the National Housing Act to assist disaster victims. Under this program, individuals or families whose residences were destroyed or damaged to such an extent that reconstruction or replacement is necessary are eligible for 100 percent financing. The previous residence must have been in the disaster area and the borrower may have been the owner of the property or a renter of the property affected. The 203(h) mortgages are financed through HUD-Approved mortgage lenders. A list of these lenders may be found at the [www.hud.gov](http://www.hud.gov) website.

## **Moratorium on FHA Insured Mortgage Foreclosures**

A moratorium on foreclosures on property directly affected by the disasters was declared for a ninety (90) day period from the date the President declared a disaster to have existed. The moratorium applies to the initiation of foreclosures AND foreclosures already in process. This moratorium has now been extended for an additional 90 days through February 28, 2006. #### **EXCEPTIONS TO CERTAIN GRANT REQUIREMENTS (WAIVERS)**

##### **HOME Program Suspensions and Waivers Related to Hurricane Katrina Recovery**

HUD is authorized to suspend certain HOME statutory requirements and waive requirements for HOME participating jurisdictions located in areas that the President declared to be disaster areas under Title IV of the Robert T. Stafford Disaster Relief and Emergency Assistance Act to assist in disaster recovery, as a result of Hurricane Katrina.

##### **Emergency Shelter Grant (ESG) Waiver of Specific Requirements**

Emergency Shelter Grant (ESG) recipients across the country called “receiving communities” are providing shelter to evacuees. HUD is waiving specific (ESG) requirements in areas that President Bush has declared major disaster areas. This waiver will enable grantees to retain their funds while homeless providers and their communities seek to rebuild service delivery systems in the wake of the Katrina disaster. This waiver is required to permit ESG grantees, especially “receiving communities,” to reprogram ESG funds to provide emergency shelters and other essential services to evacuees.
