**FIRST AMENDED ORDER AUTHORIZING CONTINUED USE OF CASH
COLLATERAL AND PROVIDING ADEQUATE PROTECTION**

IT APPEARING AND THE COURT HAVING FOUND THAT:

A. On September 20, 2006 (the "Involuntary Date"), certain petitioning creditors filed an involuntary petition for relief under Chapter 11 of the Bankruptcy Code against the above-captioned putative debtor (hereinafter referred to as, "Union" or "Debtor"). On October 3, 2006, Union consented to the order for relief.

B. Before the institution of these proceedings, GMAC Commercial Finance LLC ("GMAC/CF") provided to Union working capital financing pursuant to various loan, security and related agreements, as amended, including a Credit Agreement dated as of December 28, 2004 between Union and JPMorgan Chase Bank, N.A. ("JPMorgan"), GMAC/CF's predecessor in interest, and related loan and security documents as amended, including by a First Amendment to Credit Agreement and a Second Amendment to Credit Agreement between GMAC/CF and Union dated June 12, 2006 (collectively, as amended, the "Loan Documents"). GMAC/CF shall file copies of the relevant Loan Documents with the Court within two business days after entry of this Order.

C. On or about June 12, 2006, in connection with GMAC/CF's acquisition of JPMorgan's loans to Union and all related documents and collateral security, two of Union's major customers, General Motors Corporation ("GM") and Freightliner LLC ("Freightliner", or together with GM, the "Major Customers") entered into a Subordinated Participation Agreement with GMAC/CF (the "Participation Agreement"). Under the Participation Agreement, the Major Customers purchased approximately \$4 million of participations in GMAC/CF's loans to Union (the "Participations"). GMAC/CF loaned the Participations to Union as non-formula based

working capital loans. GMAC/CF filed a copy of the Participation Agreement with the Court. To induce GMAC/CF to continue to provide financing to Union, the Major Customers entered into an agreement that provided to GMAC/CF certain credit enhancements related to Union's accounts receivable and inventory (the "Credit Enhancement Agreement"). GMAC/CF filed a copy of the Credit Enhancement Agreement with the Court.

D. On or about July 11, 2006, Union and the Major Customers entered into an Amended and Restated Accommodation Agreement (the "Accommodation Agreement") that, among other things, granted each Major Customer an option to purchase from Union certain assets dedicated to the Major Customers' production (the "Dedicated Equipment"). With the consent of the secured creditors who claim an interest in Union's machinery and equipment, Union sold to the Major Customers certain of the dedicated equipment prior to the filing of the involuntary petition. The amounts owing by the Major Customers for the Dedicated Equipment constitute cash collateral (the "Equipment Cash Collateral"). Notwithstanding anything to the contrary in this Order, Union shall have no right to use the Equipment Cash Collateral and such cash collateral shall be subject to the terms of paragraph 13 below.

E. As of September 26, 2006, Union owed GMAC/CF, in the aggregate, the sum of \$7,282,835, excluding interest, costs, expenses (including attorneys' fees) and other charges provided under the Loan Documents that have accrued and are unpaid. All amounts owing to GMAC/CF, including principal, accrued but unpaid interest, all costs, expenses and fees called for by the Loan Documents and any contingent obligations owing by Union to GMAC/CF, whether arising prior to or subsequent to the Involuntary Date, are collectively referred to as the "Obligations".

F. Union acknowledges that the Obligations, including, but not limited to the sums specified in paragraph E above, as of the date indicated, are due and owing to GMAC/CF without setoff, defense, or counterclaim of any kind by Union. Union further acknowledges that, pursuant to the Loan Documents, GMAC/CF has: (i) a valid and properly perfected, indefeasible, first priority security interest and lien in all of Union's accounts, accounts receivable, documents, instruments, contract rights, general intangibles, including all insurance proceeds for all casualty losses, chattel paper and inventory and proceeds and products thereof, regardless of whether the same are in Union's possession (collectively, the "Current Asset Collateral"); and (ii) a valid and properly perfected, indefeasible security interest and lien in all of Union's machinery, equipment, furniture and fixtures that are subordinate to the security interest and lien held by The West Virginia Economic Development Authority (the "EDA") and Park Corporation (collectively, the "Other Secured Creditors") to the extent the Other Secured Creditors have valid, properly perfected security interests and liens and otherwise allowed secured claims. For convenience, all of the foregoing collateral held by GMAC/CF (including the Current Asset Collateral) is collectively referred to as the "Pre-Petition Collateral".

G. In consideration of GMAC/CF's consent to entry of this Order, Union has waived any and all objections to GMAC/CF's security interests and liens in the Pre-Petition Collateral, and by stipulating to the entry of the Order, Union waives and releases any and all claims against GMAC/CF, its officers, agents, employees and attorneys, including, without limitation, any affirmative defenses, counterclaims, setoffs, deductions, recoupments, known or unknown, and

any claims under Chapter 5 of the Bankruptcy Code, based on facts in existence as of the date of this Order.

H. No entities other than GMAC/CF (and the Major Customers as participants in the Obligations) have an interest in Union's cash collateral arising from the Current Asset Collateral.

I. Because GMAC/CF is unwilling to advance funds in the "gap period", Union does not have sufficient funds on hand to meet its payroll and current operating expenses on a continuing basis. Accordingly, Union has requested that GMAC/CF consent to the use of cash collateral according to the terms of this Order. GMAC/CF is acting in good faith in entering into this Order and allowing Union to use cash collateral according to the terms of this Order. Union's use of cash collateral is essential to meet Union's day-to-day cash requirements of its operations.

J. Pending a final hearing, if required, Union requires the use of cash collateral as set forth on the budget attached hereto (the "Budget") in order to avoid immediate and irreparable harm.

K. The notice and opportunity for a hearing provided to date, and the procedure set forth in paragraph 23 below, constitute sufficient notice and a hearing, and no further notice is required under 11 U.S.C. §§102 or 363, FED. R. BANKR. P. 2002, 4001, 6004 or 6007, the Local Bankruptcy Rules of the United States Bankruptcy Court for the Southern District of West Virginia (the "Local Rules"), or any other applicable rules.

L. The entry of this Order will allow Union to maintain operations and preserve the value of its assets, and, therefore, for among other reasons, is in the best interests of Union and its creditors.

M. THIS ORDER IS BEING ENTERED ON AN INTERIM BASIS PURSUANT TO FED. R. BANKR. P. 4001 AND, WITH THE EXCEPTION OF THE PROTECTION AFFORDED GMAC/CF IN PARAGRAPHS 18 AND 23 BELOW, IS SUBJECT TO THE RIGHTS OF CREDITORS AND OTHER PARTIES IN INTEREST TO OBJECT AS PROVIDED IN PARAGRAPH 23 BELOW.

NOW, THEREFORE, IT IS HEREBY ORDERED:

1. Subject to the rights of any third parties (including any creditors committee appointed herein) to object as provided below, which rights are specifically reserved, Union acknowledges that:

- (a) GMAC/CF has a valid, perfected, enforceable, unavoidable lien and security interest in the Pre-Petition Collateral having the priorities set forth in paragraph E above, which lien and security interest are not subject to avoidance, defeasance, offset, defense or counterclaim of any kind in this proceeding.

(b) Union's Obligations to GMAC/CF constitute Union's valid and binding obligations and are secured by the Pre-Petition Collateral.

2. Union may use the Current Asset Collateral and the "Post-Petition Collateral" (as defined below), including cash collateral, in the ordinary course of its business only in accordance with the terms and conditions of this Order. Unless waived in writing by GMAC/CF, before using any cash collateral, Union must deliver to GMAC/CF the Major Customers' respective reaffirmations of the Participation Agreement and Credit Enhancement Agreement in such form as is reasonably requested by GMAC/CF. Unless GMAC/CF, in its discretion, agrees otherwise and files a notice to such effect with this Court, GMAC/CF and Union's authority to use cash collateral under this Order shall terminate on the earlier to occur of (a) an Event of Default or (b) 5:00 p.m. Eastern Standard Time on October 27, 2006. After such time (or at the expiration of any extension to which GMAC/CF agrees), Union shall not use cash collateral unless otherwise ordered by the Court or as provided below.

3. All accounts receivable and all other payments due to Union on account of Current Asset Collateral, whether arising or acquired pre-petition or post-petition (the "Proceeds") must be paid directly to GMAC/CF according to the procedures in place prior to the Involuntary Date or as otherwise instructed by GMAC/CF. For convenience, Proceeds arising from Union's shipments of goods after the Involuntary Date (other than proceeds of inventory purchased pursuant to the Credit Enhancement Agreement) are referred to as the "Post-Petition Accounts". Subject to Union being otherwise in compliance with the borrowing base requirements of the Loan Documents on a consolidated pre-and post-Involuntary Date basis, GMAC/CF will transfer to Union as soon as is practicable, (a) 40% of the first \$1,585,000 in Proceeds of Post Petition Accounts, (b) 75% of Proceeds of Post Petition Accounts in excess of \$1,585,000, or (c) such greater percentage as GMAC/CF, in its discretion, may agree. GMAC/CF shall apply all Proceeds other than the portions made available to Union to reduce the Obligations. Further, from and after the time that all of Union's Obligations to GMAC/CF other than the Participations are paid in full, all Proceeds received by GMAC/CF (net of a \$100,000 cash reserve to be held by GMAC/CF for payment of Costs and otherwise as security for the Obligations) shall be turned over to Union to the extent necessary to fund the expenses set forth in the Budget.

4. Union may use the cash collateral only to fund expenses provided for in the Budget and otherwise subject to the limitations contained in the Accommodation Agreement. Any excess cash collateral arising from Current Asset Collateral must be returned to GMAC/CF at the expiration of Union's right to use cash collateral as provided in paragraph 2 above.

5. No cash collateral may be used to pay any fees, expenses or costs incurred in connection with investigating or asserting, directly or indirectly, any claims or causes of action against GMAC/CF or the Major Customers and/or any post-petition investigation or challenge, directly or indirectly, to this Order or GMAC/CF's liens or claims, or in connection with any motion filed or to be filed by Union seeking entry of an order authorizing Union to utilize GMAC/CF's cash collateral or obtain loans without GMAC/CF's written consent.

6. By consenting to Union's use of cash collateral and other Pre-Petition Collateral on the terms provided in this Order, GMAC/CF is not and shall not be deemed to have consented to any surcharge of its Collateral (as defined below).

7. As adequate protection of GMAC/CF's interest in the cash collateral that Union is allowed to use under the terms of this Order, pursuant to 11 U.S.C. §§361, 362 and 363(e), GMAC/CF is hereby granted a first-priority lien and security interest in:

- (a) all of Union's assets, including, but not limited to, all accounts, accounts receivable (including the Post-Petition Accounts), notes (and all collateral security therefore) general intangibles (including, but not limited to, any insurance proceeds), instruments, documents, chattel paper, goods, inventory, including merchandise, raw materials, supplies, work-in-process and finished goods, fixtures, equipment, machinery and furniture, all cash and cash equivalents and bank accounts and checking accounts, the Proceeds, and the products and proceeds of all of the foregoing, arising, created or acquired subsequent to the filing of the Chapter 11 Petition (collectively, the "Post-Petition Collateral"); and
- (b) the Pre-Petition Collateral.

(collectively, the "Collateral"). The security interest, lien and mortgage granted by this paragraph shall constitute a paramount and first lien, security interest and mortgage, subject only to any other valid, perfected, unavoidable pre-petition liens or security interests and mortgages of record (to the extent and priority existing as of the Involuntary Date only) as determined by this Court in a final non-appealable order to be prior in right to GMAC/CF. No security agreements or mortgages or the filing of any financing statements or mortgages shall be necessary to evidence or perfect such security interest, mortgages and lien. Union, however, shall execute any documents reasonably requested at any time by GMAC/CF to memorialize or evidence these liens, security interests and mortgages. GMAC/CF shall have all the rights and remedies of a secured creditor in connection with the security interest and lien granted by this paragraph, except to the extent that such rights and remedies may be affected by the Bankruptcy Code.

8. As further adequate protection of GMAC/CF's interest in the Pre-Petition Collateral:

- (a) GMAC/CF may apply any Proceeds it receives to pay: (i) accrued but unpaid interest on the Obligations other than that portion represented by the Participations, which interest shall accrue; (ii) all fees called for by the Loan Documents; (iii) a one-time fee of \$50,000 to reimburse GMAC/CF for the incremental costs and expenses of providing the extra servicing and monitoring necessary to implement this Order (and any extensions agreed to by GMAC/CF); and (iv) the Costs (as defined below) incurred from time to time (such reimbursement to GMAC/CF is subject to the rights of Union, any committee appointed to subsequently review and, if appropriate, object to the reasonableness of the Costs reimbursed);

- (b) Union shall maintain all insurance coverage and pay all taxes and other expenses set forth as required by the Loan Documents; and
- (c) Union shall observe and comply with all terms and conditions of the Loan Documents relating to the amount, value, condition, preservation, maintenance and protection of the Collateral, which provisions are incorporated herein by reference.

For purposes of this Order, the term "Costs" means all fees, costs and expenses for which Union is obligated to pay or reimburse GMAC/CF under the Loan Documents, including legal fees and costs incurred by GMAC/CF in the handling of any and all matters in, arising from, or related to, this bankruptcy proceeding and any subsequent proceedings; the Costs are part of the Obligations and secured by the Collateral to the extent permitted by 11 U.S.C. §506(b).

9. The occurrence of one or more of the following constitutes an event of default hereunder (and under the Loan Documents) unless waived in writing by GMAC/CF ("Event of Default"):

- (a) A breach or default of any term, covenant or condition of this Order;
- (b) Union fails to maintain adequate insurance on the Collateral;
- (c) Union fails to pay, when due, any tax or other obligation that may give rise to a statutory or other lien on the Collateral;
- (d) A trustee is appointed or this proceeding is converted to a proceeding under Chapter 7 of the Bankruptcy Code;
- (e) Union fails to provide GMAC/CF with the reports required by the Loan Documents;
- (f) Union defaults under the terms and conditions of any other order entered pursuant to 11 U.S.C. §§361, 362, 363 and 364 without curing such default within any applicable cure period provided in such order;
- (g) A motion for an expedited sale procedure order reasonably acceptable to GMAC/CF and the Major Customers is not filed on or before October 13, 2006; or
- (h) There is a further or additional material default under the Loan Documents, the Accommodation Agreement or the Access and Security Agreement executed in connection therewith.

10. Notwithstanding anything herein to the contrary, nothing in this Order shall be deemed to limit or restrict GMAC/CF's or Union's right, at any time, to seek any relief afforded under the Bankruptcy Code, so long as the relief sought is not inconsistent with this Order.

11. Union shall cease using all cash collateral in its possession or control five days after receipt of written notice from GMAC/CF that an Event of Default has occurred (or immediately, in the case of an Event of Default under paragraph 9(e) above). During such five day period (if the Event of Default is other than under paragraph 9(e) above), Union shall use cash collateral, if any, turned over by GMAC/CF prior to the time Union received notice from GMAC/CF only in the ordinary course of its operations and then only to the extent absolutely necessary to avoid irreparable harm to the estate. Upon the filing a motion seeking to enforce any remedies under this Order, subject to this Court's docket, GMAC/CF shall be entitled to a hearing on not more than two days' notice to Union, the Office of the United States Trustee, the Major Customers and any committee appointed herein at which time GMAC/CF may seek one or more of the following:

- (a) The lifting of the automatic stay under 11 U.S.C. § 362 to permit GMAC/CF to take possession of all or any portion of the Collateral;
- (b) The appointment of a trustee in this proceeding; or
- (c) Such further or other relief as provided in the Loan Documents, the Bankruptcy Code, or applicable non-bankruptcy law.

12. The terms of this Order and GMAC/CF's consent to Union's use of proceeds of the Collateral as provided in this Order, will not be deemed to be a waiver of any part of the Obligations or a waiver of any claims GMAC/CF may have against any third parties (including the Major Customers under the Credit Enhancement Agreement and the Participation Agreement), and is without prejudice to any of GMAC/CF's rights, interests and claims of any nature against any person or entity, including, without limitation, Union's current and former account debtors, which rights, claims and interests are expressly reserved.

13. The Major Customers shall pay the Equipment Cash Collateral directly to the EDA to reduce Union's obligations to the EDA (to the extent that the Major Customers did not do so prior to the Involuntary Date); such amount shall be subject to disgorgement if this Court later determines that the EDA is not entitled to receive the Equipment Cash Collateral. Upon remitting the applicable Equipment Cash Collateral, each Major Customer shall have the immediate right to remove their respective Dedicated Equipment. In addition, (i) each Major Customer shall have the immediate right to remove any tooling, fixtures, gauges and related items that Union has previously acknowledged are owned by the Major Customers, and (ii) subject to entry of this Order, Union shall ship parts banks as requested by the Major Customers. The Debtor shall immediately commence shipping all such items.

14. Union and its counsel shall give GMAC/CF notice, through its attorneys, Honigman Miller Schwartz and Cohn LLP, of all motions, requests, applications, proceedings, proposed orders and orders entered relating to this Chapter 11 case and any proceedings in connection with said case. Further, Union and its counsel shall provide GMAC/CF with copies of all reports, statements, schedules, motions, pleadings and other papers filed with or submitted to this Court or the U.S. Trustee. Except for routine reports and the like that may be sent by first class mail, such notices or papers, unless otherwise stated in writing and signed by GMAC/CF,

shall be delivered by both electronic mail to both dfb@honigman.com and jbellaver@gmaccf.com and by overnight courier or telecopier transmission to Honigman Miller Schwartz and Cohn LLP, Attention: Donald F. Baty, Jr., Esq., 2290 First National Building, Detroit, Michigan 48226 (telecopier no. 313-465-7315).

15. No delay on the part of GMAC/CF in exercising any right, power or privilege hereunder shall operate as a waiver thereof nor shall any single or partial exercise of any right, power or privilege hereunder preclude other or further exercise thereof, or the exercise of any other right, power or privilege. The rights and remedies hereunder specified are cumulative and not exclusive of any rights or remedies that GMAC/CF may otherwise have.

16. To the extent that, notwithstanding the adequate protection granted to GMAC/CF hereunder, GMAC/CF has allowable claims in this proceeding arising from the use of Pre-Petition Collateral, then GMAC/CF's claims shall have priority pursuant to 11 U.S.C. §507(b), whether in this Chapter 11 proceeding or any subsequent Chapter 7 proceeding.

17. The entry of this Order shall not constitute a finding that GMAC/CF is or is not adequately protected regarding Union's use of cash and non-cash collateral after the expiration of Union's authority under this Order to use cash collateral.

18. If any or all of the provisions of this Order are hereafter modified, vacated or stayed by subsequent order of this or any other Court or the instant involuntary proceedings are dismissed, such modification, dismissal, vacation or stay shall not affect the validity, enforceability or security granted for any diminution in the Collateral, including, without limitation, the use of cash collateral, and that is incurred prior to the effective date of such modification, dismissal, vacation or stay, or the validity and enforceability of any lien or priority authorized hereby with respect to any such debt to GMAC/CF, and notwithstanding such modification, dismissal, vacation or stay, GMAC/CF shall be entitled to all of the rights, privileges and benefits, including, without limitation, the security interests and priorities granted herein such diminution. Further, if the instant involuntary proceedings are dismissed and as a result thereof this Order is vacated or expunged, this Order shall nonetheless be deemed to be an enforceable agreement between the parties stipulating to entry of this Order.

19. Each of GMAC/CF, Union, GM and Freightliner reserves any and all of their respective rights to enforce the terms of, or assert a claim for breach under, the Accommodation Agreement, the Loan Documents, and/or the Access and Security Agreement. To the extent that any party seeks relief under such agreements, relief may be sought by motion (rather than an adversary proceeding), upon reasonable notice, and each of the parties consents to such procedure.

20. GMAC/CF, GM, Freightliner and the Debtor acknowledge that \$1,900,000 of the disbursement in the "Check Run" line in the Budget are subject to review by the Debtor, the Major Customers' and that such account will be reduced to eliminate prepetition obligations and/or increased for any accelerated postpetition vendor payments the Debtor is required to make, but in no event will the "Check Run" exceed \$1,900,000.

21. Subject to GMAC/CF's receipt of at least \$1,650,000 in payments from the Major Customers, in respect of Debtor's pre-petition accounts from and after October 5, 2006, Freightliner shall earmark and pay to Alcoa the amount of \$624,493.49 on Debtor's behalf for shipments of raw materials to Debtor from September 11, 2006 to September 14, 2006. As a result of the payment to Alcoa, Freightliner shall be allowed to setoff the amount paid to Alcoa against any invoices received from Debtor after the Involuntary Date. The payment on behalf of Freightliner to Alcoa is not deemed to be a preferential transfer as it results in the release of Alcoa's right to assert a reclamation claim and such payment is required in order to release the remaining raw materials.

22. The entry of this Order shall resolve in all respects the Motion of the Debtor to Modify Terms of Use of Cash Collateral, Docket No. 48, and the Motion of GM to Compel Debtor to Comply with the Order Authorizing Emergency Use of Cash Collateral, Docket No. 51.

23. Union shall give notice (no later than 48 hours after entry of an Order) to all creditors and interested parties entitled to receive notice pursuant to FED. R. BANKR. P. 4001, all parties who may claim an interest in the collateral, and such other parties as the Court may require, that this Order has been entered. Objections to this Order may be filed by any party in interest and must be filed with the Court and served upon counsel for Union and counsel for GMAC/CF no later than 15 days after the date of this Order. If an objection is timely filed, a hearing will be held on November 7, 2006 at 10:00am, at which time the objecting party or parties shall be given the opportunity to show cause why this Order should not become a final Order. If a timely objection is not filed, this Order shall become final without any further action by this Court. Notwithstanding the outcome of any hearing on any objection to this Order, GMAC/CF shall be entitled to the liens, priorities and other rights provided in this Order to protect GMAC/CF to the extent of any use of GMAC/CF's Collateral, including, without limitation, cash collateral, since the Involuntary Date. In the event that this Order becomes a final order in accordance with the above, then it shall be deemed a final order for all purposes, including, without limitation, appeal and otherwise, and shall be deemed to be a final judgment and order under FED. R. BANKR. P. 4001, 8001(a) and 7054 and FED. RULE CIV. P. 54(b) except with respect to any creditors committee in which event this Order shall be deemed to be a final judgment and order under FED. R. BANKR. P. 4001, 8001(a) and 7054 and FED. RULE CIV. P. 54(b) 45 days from the date of service of this Order on the 20 largest unsecured creditors.


