## **Man Who Led Police on a Car and Foot Chase Arrested by U.S. Marshals**

**Portland, OR-** Yesterday afternoon at 4:30 PM, Sean Ivan Detrick, a 37 year-old white male, was arrested in Selwood Park by members of the U.S. Marshals Oregon Fugitive Task Force. At the time of the arrest, Detrick was sitting in a parked Chrysler Sebring along with Lisa Ann Myers. Sellwood Park is located a few blocks away from Myers residence. Detrick was arrested on a warrant for Unlawful Use of a Motor Vehicle (UUMV) and was also charged with Robbery I, and Kidnapping stemming from an earlier incident involving an alleged robbery at knifepoint. Meyers was arrested on a state Probation Violation.

Sean Detrick was profiled on FOX 12 in early February which brought Detrick to the public's view after he led West Linn Police on a vehicle chase ending with Detrick evading capture while on foot. During that police chase, several witnesses said they spotted Detrick "dashing through neighborhood yards." At the time, a Volkswagen Jetta was also stolen out of a driveway in the same neighborhood. According to a Portland Police Bureau Detective assigned to the Fugitive Task Force, a viewer who recognized Detrick from the FOX 12 show called police when he saw a man fitting his description at a motel in Vancouver, Washington.

Among items recovered during Detrick's arrest were just under \$4000 in \$50 and \$2 dollar bills as well as jewelry from an alleged burglary in the Salem area. Also found were quantities of Methamphetamine, cocaine, and drug contraband. Additional charges of drug possession, burglary, identity theft, and witness tampering are being investigated. Also found was a backpack containing a Vancouver High School student's school books and the only copy of his senior project. The backpack had been reported stolen the previous day following a car prow. When police returned the school books, a very relieved and grateful student also described his missing jacket. When Police returned to the holding cell they recovered a school jacket fitting that description being worn by Myers. Myers was on Multnomah County probation for the original conviction of Identity Theft which was linked to a string of burglaries.

Detrick was lodged at the Multnomah County Detention Center on Sunday night. His scheduled court appearance will be in Multnomah Circuit Court on Monday.
