Directory of Alternate Transportation

Since you do not qualify for Special Mode of Transportation, seniors and disabled adults are encouraged to look into Alternate Modes of Transportation. Options are arranged by county via links on the side of each page.

For each county there is a designated transportation service that is supported by state funds. State designated agencies are marked with “**”

Patients with Medicaid should call the state-funded transportation service and ask for a referral to that county's Medicaid-specific service. Patients over 60 years old can also call (877) 222-3737.

Disease-specific agencies in each county will often provide transportation services. Contact the town clerk at your town hall for information about town specific transportation services.

Transportation provided has limitations. Generally, advance notice of a week or more is required, patients must be able to get in and out of vehicle without assistance, pick-up is curbside and transportation is limited to specific days or hours.
