### **FOREWORD**

This International Market Insight (IMI) is a compilation of development projects funded by the Asian Development Bank (ADB). It is released monthly to alert U.S. firms of new consulting services projects under the ADB Technical Assistance (TA) programs. Technical Assistance is used to prepare and implement projects and support advisory and regional activities of the bank. In 2005, U.S. firms - including many small consulting firms - succeeded in winning US\$46 million of ADB-funded national Technical Assistance contracts from a total consulting budget of US\$410 million. These IMIs can be the firm's link to these opportunities.

**Objectives and Scope**: The goal of the TA is to support implementation of the CCS reform under the Rural Cooperative Credit Restructuring and Development Program (the Program) and its objective is expeditious commencement of CCS reform.

**Objectives and Scope:** The objectives of the project are to enhance tourism-based economic development in northern Lao PDR by upgrading the airport in Luang Prabang to accommodate airplane types that are in common use in regional air traffic. The project also aims to support the integration of northern Lao PDR into the GMS air traffic network by transforming Luang Prabang Airport into a regional air traffic hub.

Consulting Services: An international consulting firm in association with national consultants will be selected and engaged by ADB, using the quality and cost-based selection method. The consultants will be engaged by ADB in accordance with the Guidelines on the Use of Consultants. The simplified technical proposal procedure will be used to select the consultants. A total of about 17 person-months of international and 51 person-months of national consulting services will be required. In addition, there will be a lump-sum input of \$20,000 to cover engineering and other surveys to be implemented by the consulting firm. The consultants will have extensive experience in (i) transport economics, including related financial management; (ii) economic and financial evaluation of airport projects including institutional arrangements and private sector involvement; (iii) airport engineering; and (iv) environmental, social, and poverty impact assessments including resettlement. To facilitate the work and ensure that DCA gains technical expertise and knowledge, the consultant team will work closely with counterpart technical experts from DCA. DCA has agreed to provide the counterpart technical staff, who will assist with the necessary surveys and other works in a timely manner.

# **Submitting Expressions of Interest**

Selection of consultants for technical assistance grant is based on the consultant's prior Expression of Interest (EOI). A good EOI should reflect the firm's experience and expertise in relation to the ADB project being sought. It is important for a U.S. firm to emphasize this or similar project experience in the country or in a similar geographic area rather than state a general profile of its consulting activities. When submitting an EOI, the project name should exactly match the one listed in this report to avoid confusion. Each project requires a separate EOI.

An EOI should be submitted on-line through the ADB website at http://www.adb.org. Firms may send a hardcopy follow-up to the Director, Central Operations Services 1 Division or to the Director, Central Operations Services 2 Division, with a copy to the ADB Project Officer.

## Registering Consulting Firms and/or Individual Consultants

Prior to submitting an EOI, consulting firms and individual consultants are required to register themselves online at http://www.adb.org/consulting - DACON (Data on Consulting Firms) system, or the DICON (Data on Individual Consultants) system. Otherwise, their EOIs will not be accepted.

ADB's DACON (http://www.adb.org/Consulting/dacon.asp) is a database of firms and other organizations from the ADB's member countries that are qualified to provide consulting services for ADB projects. The DACON contains information on the experience and capacity of the firms and organizations. ADB requires firms or organizations to register on the DACON so that the ADB can consider them for short-listing for a technical assistance project. The term "firm or organization" covers all sources of consultants, such as consulting firms, government agencies, public sector organizations, national and international institutions and non-government organizations.

The DICON (http://www.adb.org/Consulting/dicon.asp) system contains the names of persons who are citizens of ADB's member countries; are at the forefront of their respective fields; and may be practicing consultants or employees, whose organizations are prepared to release them for short periods to serve ADB; or retired persons with special experience who are still active.
