ORDER GRANTING DEFERRAL OF EFFECTIVE DATE OF RATES

(Issued May 19, 2005)

1. On May 13, 2005, Xcel Energy Services, Inc. (Xcel), on behalf of its affiliated public utility operating companies, Public Service Company of Colorado and Southwestern Public Service Company, filed a request that the Commission defer the effective date of rates filed in Docket No. ER04-1174-000 from May 20, 2005 to June 1, 2005. In support, Xcel explains that the rates at issue (which include formula rates for transmission service, based on a prior year's Form No. 1 data) had been accepted and suspended for five months, to become effective on May 20, 2005, subject to refund, but that they would remain in effect for only 12 days, until June 1, 2005, when new rates would become effective. Xcel states that an extension to June 1, 2005 would allow Xcel to avoid having to calculate and charge rates for 12 days (and likewise defer the effectiveness of the rates from mid-month to the start of a new calendar month), and would allow the lower, currently effective rates to remain in place for those 12 days and so avoid a rate increase to customers for those 12 days. Xcel also states that it has

conferred with counsel for the affected customers who are parties to this proceeding and that they have authorized Xcel to state that they do not object to the requested deferral of the effective date.

2. In these circumstances, the Commission will grant the requested deferral and allow an effective date of June 1, 2005.³
