Please, do not build as recommended, the proposed transmission line alternative along I-66 corridor linking the Aldie substation to Meadow Brook. The sepentine route should/must be a straight-line from source to source, less impact and better quality transmission minimizing loss.

Do not run a 500kV powerline well south, diagonally through my livestock field and new fencing, taking my barn, hay building and land values. Do not continue westward right in front of my home and as far as we can see 50' above the treeline felling historic hardwoods in your path - this is a 150'clear transmission swath that allows no buildings within 500' on either side of the easement for safety reasons. My front door! And in time, Dominion Power will return to take more, like a cancer.

Choose an interstate swath, bury cables where necessary, compromise.

Put the generating responsibility on the localities with the demand - where the demand originates. Connect a logical regional grid system, not a hyper-honeycomb the DC area because human error blackened New York City in the past. Or because Fairfax County gridlock development needs excessive power a few days per year but won't allow electricity to be generated there.

Force self-sufficient and alternative energy production. Mandate an Energy Policy for Conservation reducing demand - apparently central government is the only way to get conservation underway.

Look at open land and preserved areas like the resources they are, and not a clear path to profit by commercial entities in the wake of the 9/11 panic-side economics, "Do something, even if it's wrong, do something."

Dear Secretary Bodman,

Please stop the random swath proposed by Dominion Virginia Powerline that is justified by the proposed NIETC (National Interest Electric Transmission Corridor) and the PJM Interconnection (regional transportation organization). I am not a politician, nor an expert from whom profound statements can be gleaned in opposition. I am a landowner in the path of this rural invasion because my farm lies in proximity to the I-66 corridor outside Haymarket, Virginia, about forty minutes from Washington DC. I write this near manifesto out of the frustration to be heard and recognized as important in the decision making process. My focus is the proposed swath through Thoroughfare Gap, Virginia, the Meadow Brook – Loudoun 500kV Transmission Line. My family is one of hundreds of families whose lives will be changed: robbed of land, land values, development rights and privacy in the path of this invasion.

The path along I-66 as it is called, is offered today before the Virginia SCC and considered "the alternate" - <u>for now</u>. Said path, is a zigzag pattern of epic proportions around parcels in *preservation easements*, generally set aside for several generations by those preserving wealth. This proposed route penalizes farmland like mine where my children would like to build their homes and continue to raise their families, here as they were raised. Development rights are few by right, but enough to keep our family together a right prohibited by *preservation easement* commitment. So we are your target, we are naked, vulnerable and attractive for power company domain because we hand cleared this 60-acre parcel of livestock fields through which you have proposed to cut diagonally, a bull's eye that will have no marketability or value when you finish. It took me 15 years to open those fields, to build the barn and hay building. Dominion Power and cohort Allegany Power have proposed snaking through my land east to west, family land already bisected north to south by their major supply line and substation with partner NOVEC.

If DoE is determined to allow, to force the taking of private lands - <u>then take land in a</u> <u>straight line from source to source</u>. Take the least impact route, parallel the interstate highway system. Buildings, houses and *preservation* lands share these routes but the impact is smaller than the proposed serpentine swath where houses and buildings exist, too and will be lost in many cases, well beyond what Dominion Power is willing to admit today. From Haymarket through Thoroughfare Gap, there is a wide, generally

unpopulated margin parallel I-66 – it has been ignored and the proposed line route cuts deeply, miles into the countryside. Use the highway contiguous properties that already bear the scars of progress where once quiet farmland rested. The damage is done. Pay a fair price for the parcels. Group utilities along existing interstate highway parallel lands, already open and accessible. Put the transmission lines underground in sensitive areas, through the irreplaceable Piedmont region. Respect private landowners.

The proposed route:

Nearest my farm, the proposed swath runs south along an Afro-American community boundary, land granted to freedmen. Approximately following Beverly Road south next to the railroad tracks, it will travel the property lines of the Cloverland (Partnership) LLC crossing Broad Run River westward. Turning north it will cut through an old forest whose oaks date to the early 1800's where moss grows up the trunks and piles of field stones are abundant, likely gathered by slaves. Most Americans will live a lifetime never suspecting that woodland like this exists; my husband and I owned this 200 acre parcel, then sold to preservationists for permanence. This land is so beautiful – it steals your breath away. The environment that makes such unique lowland, will never recover from clear-cut ambitions, this is ignorant.

From the forest you enter my land, 100+ acres, tracking the county boundaries between Prince William and Fauquier. The powerline will render bald a 150' swath in the cedar fields now in process of reclamation, formerly dairy fields being allowed to reforest to protect the Chesapeake Bay Watershed. Stone fences divide fields where once soldiers hid and balanced muskets during the Thoroughfare Gap battles centered less than one mile to the north. They too, will be removed in the name of national security/civil defense. Trekking through my new fences and diagonally across my cattle field the line meets Broad Run River again; not to cross but to parallel on a narrow ridge and steep 40' bank to the river's edge where old growth trees provide erosion control. A unique environment, fern covered, a tundra pad little bears roll downhill to the river learning to negotiate round bodies and short legs. No erosion control manmade can keep this fragile area from being destroyed. Broad Run through the efforts of all riverside landowners is pristine a river unchanged since my first swim at 16 – today I am 58. My children, my grandchildren have learned to fish and swim in that river from which soldiers in the 1850's north and south drank. My 93 year old father says, "If you close your eyes on river's edge, you can hear the Yankees comin', and the guns at Manassas..."

My barn will be lost as well as our hay storage building under the powerlines. My barn was finished with wood cut, lumber planked, dried, planed and erected on this farm. Years. It took years of blood, sweat and tears. Our horses were born in that barn. Old telephone poles became the support members for the hay building we built using discarded materials. It is an amazing farm today. It has taken my lifetime to grow.

The powerline continues onto Mark's land, 70 acres in Fauquier County, tracking several hundred yards northward. It then turns 90 degrees west climbing a foothill right in front of my home. There it crosses an existing and wide NOVEC (Northern Virginia Electric Cooperative) easement continuing through a wooded patch, crosses a Dominion Virginia

Power line on Beverley's Mill Road and up Biscuit Mountain westward. Our family has already granted these easements and, a one-acre substation with access road. A receiving/transfer station for primary power from Virginia Power generating sources.

Rural life:

Our community is laced with old, leaning and over-weighted transmission lines while new neighborhoods are clean, utilities are underground. The 500kV line on 125' trellises Iron Men will be even more intrusive, again aboveground and. 50' over the tree line. Rural areas have few or no services. Roads are lined with relentless power poles with subcontract service lines attached. We have no access by landline to broadband high speed, no cable service either.

<u>Now</u>, you want to cross our land again diagonally – yet, easements exist north and west. The wide corridor of I-66 is resistance free except, Dominion and the Virginia Highway Department don't cooperate, have no dialogue. All part of infrastructure, cooperation has become essential. This choice through our land is far from a direct line to the powergrid goals, which falls much farther north through Loudoun where there are easements – but somehow, that isn't an option?? Dominion Power has bullied and bought influencegaining control over energy production by unbridled monopoly privilege. <u>Wealth is built</u> <u>over the blood of others – so political powers and monopoly privilege take our land because you can?</u>

<u>The truth</u> about what will happen to my farm is not the presentation by Virginia Power. The boots-on-the-ground will be the crews, outsourced generally West Virginia linemen, tree guys with whom I have experience. Ingress/egress will be my driveways, heavy trucks and equipment will travel my farm roads, crush pipes use and not repair damage, and will toss their cups and wrappers leaving. They will enter my property without permission. They may or not, close gates. They will come all year round, make repairs and improvements to their lines use my land and the swath will not be maintained. My family feels threatened and without privacy – the privacy we bought and have paid for, defended and earned.

Poison has become line maintenance crew's favorite way to eliminate emerging forest cover. I don't use poison; I have animals and small children, wildlife is unbelievably abundant because we protect it, keep buffers, limit hunting, fight fires and are good stewards of the land. These are critical components of life in a rural community. Our land is simply borrowed from our children and we are committed to preservation without an intermediary.

Gates keep trespassers out and animals in. When utility men need access and cannot contact the owner, they simply cut the fences and chains. The crew chief carries a roll of cash. When the landowner or overseer finds them, or tracks them down, they pay for damages in cash, the landowner repairs the damage. When a fence is cut here, animals leave the compound easily finding their way to the roadway. Cars hit them. They race wildly for miles and enter major highways - the liability of the landowner's. Escaped animals are usually killed; panic and ignorance by the general public as well as police

who's liberal use of lights and sirens, almost always end the animal's life. If you have ever birthed and raised a foal or pulled a calf, you are repulsed and heart-sickened by this probability. The final thread in this litany - we raise sport horses, this is a breeding farm. Everyone knows, horses will eat cigarettes; they do not know, ingested tobacco causes colic and death. How would you suggest I protect my herd?

We are four generations living here now. This powerline will take away our ability to freely use our land, to create income and raise our children unopposed by trespassers. I built my home here thirty years ago and cleared the land. I raised two children here. Now my grandchildren live here. My son will marry this spring and was in process to build his home on the edge of the cattle field, now overlooking by a football field the proposed powerline. My son has just refenced that cattle field you intend to take by eminent domain. His right hand was crushed in an accident involving that fencing equipment 16 months ago; he can use all of his fingers today, a miracle. For months I buttoned his shirts and we cried. Our hearts and souls are vested in this land.

I have put every dime I have ever had to spend, into building this farm from scratch. I traded land and materials to make it functional. Collected the rocks by hand from our fields for our home and outbuildings. I have, my children have built the buildings. I have educated my children in Virginia schools and colleges, lead the Girl Scouts, participated in church activities, voted and contributed to society and the quality of our nation. My assets, my livelihood, my retirement is this farm. Disney threatened us, Colonial Downs type racetrack came and proposed to spray raw human sewage on the woodlands above the river, mountain top towers in the path of helicopters to Mount Weather and planes landing at Dulles, construction dumpsite landfills and burn pits – we have fought them all - fought for the right to peaceful enjoyment, clean environment and safety. Battlefield historians have identified encampment areas on our land. History cannot be recreated, we are preserving the forest; someday others will explore and learn history's lessons here. Human health concerns: No conclusive evidence they say about 500kV transfer and human cell damage – logic tells you it's not healthy to live near this monster. How much current is emitted, lost in travel over long miles northeast? An engineer, an energy expert told us that if you stand near the powerlines holding a fluorescent bulb, it would light in your hand! Don't park a tractor near the transmission lines - you will brave shocks to retrieve it. And the swath -150' but there are no structures allowed 500' to either side of the swath. My home, are you taking my home, too? It's quite near.

<u>Enough.</u> Find a route and an holistic line design that does not rob people of their futures and investments. Powerline easements exist abundantly now. Centralize power production by local regions. Civil defense can be protected by sensible transmission lines at lower altitudes and within a comprehensive pattern between sources. But the burden of power production must be borne by the region from which the demand is generated.

The NIETC and PJM plan guarantees profit to big power companies at the expense of those smaller whose voices are being ignored and land exploited. Power production capability exists in the growing populations in New York – ex: turn on Shoreham Nuclear Plant on Long Island. Turn on and build production where it is needed – it may not mean

profit for Virginia Power, but they are not the only "candy store in town," east of the Mississippi River. Their partner: Allegany's plants are critically outdated as they are said to produce energy by the dirtiest materials processes, emit acid and pollution responsible for the continuing destruction of National Forests in the east – why hasn't that been changed? Mandate change, mandate bag houses to filter as example, close them if they don't comply. Fees alone could fund new low or free pollution plants and alternative fuels. Simple - take charge. Our world cannot afford this pollution any longer. Clean the environment as committed to. <u>Be strong, you have the power to make change, and the responsibility</u>. If New York can build water lines 100 stories under the city, they can produce power for their state and region. Don't penalize Virginia by forcing us to live with vulgar transmission lines for neighbors outsourcing even their trash to Virginia.

Fool me once...Southern kindness and grace with a smile. Fool me twice...I am a Fool.

We, the citizens of Virginia have built and paid for power production. Virginian's have borne the burden of nuclear plants. We did our homework. We have enough power for reasonable usage for generations to come. The government needs to take the helm and penalize abusers of power; mandate responsible technology like fluorescent bulbs to preserve and use production sensibly by means of the generation capabilities we already have. No nation can create enough power for arrogant use of energy. Taking our land to service those that choose not to produce adequate power for their own needs is wrong and egotistical. Mandate energy efficiency; begin now to enforce reasonable usage.

<u>Take care of us. We have paid our dues</u>. We have power plants. We are pollution conscious and preservationists. Respect those of us that have played the game fairly. Reward those of us that already have powerlines crossing their land. Don't scar our land any further. The Piedmont can never be reclaimed and it is a national treasure. Even the FAA had concerns when we red PEC balloons were elevated to depict the proposed towers for visiting Congressmen.

<u>Please, do not approve as recommended, the proposed transmission line along I-66</u> <u>corridor linking the Aldie substation to Meadow Brook.</u> Do not run a 500kV powerline through my field and over my barn then turn it at the top of a foothill right in front of my home and continue it as far as we can see. This is an arrogant outrage of government power fostering commercial enterprise blind to property rights and future generations that will inherit American soil. Put the generating responsibility on the localities with the demand. Mandate an <u>Energy Policy for Conservation</u> reducing demand. Look at open land and preserved areas like the resources they are, and not a clear path to profit by commercial entities in the wake of the 9/11 *panic-side* economics, "*Do something, even if it's wrong, do something.*"

1) Supply Source: Your reports and graphics show that energy needed for San Diego must come from Imperial County. That is a false presumption. Energy can be generated in San Diego County using existing technology. For example, solar (by individuals, businesses, and others); electrical generation plants in San Diego (e.g., the existing one in Escondido); water generators such as that proposed for Lake Elsinore; wind, etc.

2) National security: Making San Diego County dependent on a few wires strung from Imperial County places San Diego at major risk from terrorist attacks or natural disasters (wildfires and earthquakes). Generating energy in various locations using various methods in San Diego County eliminates or minimizes this threat.

3) Demand Reduction: Increasing supply is only side of the energy requirement equation; the other side is reducing demand. Either side can be used to balance requirements. It's like a personal or govt budget: make more or spend less. Demand can be reduced using existing technologies plus govt mandates and incentives.

4) Route: Even if a Imperial to San Diego powerline was needed, there is no energy requirement to run it through our beautiful state parks (Anza-Borrego) or national forest (Cleveland). San Deigo Gas & Electric wants to do this so it costs them less. These lands belong to the people, not private businesses like San Diego Gas and Electric who only wants to increase shareholder profits.
