I understand that Allegheny Energy is considering constructing a new 500 kV transmission power line through western Pennsylvania. I oppose construction of the 500 kV Line because, it is simply not needed. We have enough power generating stations in Washington and Greene Counties to provide more than 3800 Mega Watt of power which is way more then the average of 700 Mega Watt that is needed right now to keep Washington and Greene Counties up and running. The designation of a national corridor where private energy providers have the government's right to eminent domain to establish new electric transmission lines is horrible national energy policy and will ultimately be proven to be unconstitutional. The corridors are unconstitutional because:

• Private property will be subject to taking via eminent domain at the whim of every for-profit, deregulated power utility in the corridor. The constitution expressly prohibits the taking of private property by for- profit, non government entities for corporate gain. Unless all power utilities are willing to be nationalized, they should not have the right to eminent domain. In the light of deregulation, present-day electric utilities have no appearance of a public service utility.

• State eminent domain laws are not designed to regulate this type of transmission line expansion and do not safe guard the property owners' rights. As a result, these national corridors circumvent any assurances of just compensation for property owners damaged by potential new transmission lines.

• These national corridors cannot over-ride other US legislation, such as NEPA. The proposed corridors are proceeding without regard to NEPA process, which has been in effect for over 20 years to ensure that all alternatives to any major federal action are evaluated and that any action taken does not preclude future alternatives and produce unmitigated environmental, cultural, and social damages.

These national corridors are horrible national energy policy and a global warming fiasco because:

• At this time of international and national concern about global warming, these electric transmission corridors are specifically designed to transport coalgenerated electric power (high carbon source) to satisfy unmanaged demand. This type of growth should be prohibited by the federal government as part of a comprehensive energy policy and not promoted by these national corridors.

• Demand management, energy conservation (residential, industrial, commercial), and development of alternative energy sources and satellite electric generation must be encouraged. From a health risk point of view, as well as other points which are below, we oppose the Allegheny Power 500 Kilovolt Towers in our backyard as well as our neighbors backyards, be they next door or in a neighboring state.

1) There has not been an adequate consideration of specific alternatives to new transmission lines, including a full range of demand management and peak

demand reduction measures, energy conservation measures, renewable sources, new generation capacity of energy located nearer the East Coast, and alternative transmission technologies and upgrades.

2) There has not been an assessment of impacts on human health and the environment, a requirement by the National Environmental Policy Act which is reasonable given the demonstrated potential impacts on historic, scenic, natural, and cultural resources in the proposed corridor.

3) Allegheny should be required to provide the public with the data and assumptions to enable independent verification of the claimed potential for power disruptions.

4) In Allegheny Power's proposal to DOE, they admit they do not meet all of the criteria for NIET designation. They also state that these criteria should not be applied rigidly by DOE, even though the criteria are meant to determine whether projects are worthy of NIET designation.

Please understand that Allegheny Power is a For-Profit Organization, where they are trying to increase profits by any means necessary. Even if it means endangering our children, our environment, our country's beauty or our personal bank accounts. Most people in our region are low to middle income families; this includes many elderly, which are trying to make ends meet, with a hike in energy rates they will be forced to cut back on other essentials to pay the energy bills.

I am opposed to designating National Energy Corridors in particular the proposed NYRI line that will run through our communities in New York State.

Approximately 90 percent of the path of these lines are along rail lines. NYRI officials admitted they had not considered that possibility of safety concerns if there was a train derailment or accident.

NYRI officials also admitted that their company considered no other alternatives to down state power needs, such as conservation or additional generating capacity, and only considered alternate routes for the power line. This is significant because the applicable law requires that an applicant for transmission line approval demonstrate that they considered alternatives.

According to former State Senator Raymond Meier this proposal would represent an annual estimated \$166 million drain on the upstate New York economy but the figures would probably be much higher and do not take into consideration the devastation to our health, safety, property values and businesses. 

Need for lines could be offset with more regional generation

All of central Pennsylvania, including Cumberland, Dauphin, Lancaster, Perry and York counties, is in a proposed Mid-Atlantic Area National Corridor for highvoltage transmission lines designated last week by the U.S. Department of Energy.

Under the Energy Policy Act of 2005, the secretary of energy is directed to

establish national power line corridors in areas of high electric transmission congestion. A second transmission corridor was designated in California, Nevada and Arizona.

As Energy Secretary Samuel Bodman noted, these designa tions neither direct the construction of power lines nor lay out their routes. What they do is be gin a legal process in which a utili ty or other power pro vider failing to gain ap proval through the state for a new power line can take its case to the Federal Energy Regulatory Commission.

Ostensibly, the issuance of these draft national corridors is supposed to spark a "full consideration of all options available" to meet electric demand. This could include "more local generation, transmission capacity, demand response (reducing consumption at times of peak usage) and energy efficiency measures," according to the Energy Department.

Our view has been that far fewer new power lines would be needed if every region strove to provide its own electric generation. According to Bodman, New York, Baltimore, Washington and northern Virginia could be looking at "involuntary service curtailments, even rolling blackouts," by 2011; likeise in northern New Jersey by 2014 and central Pennsylvania by 2019.

Geography dictates that Pennsylvania, which already is crisscrossed by various man-made corridors -- including power lines, pipelines, interstate highways and railroad lines -- stands to be especially affected as a consequence of the expanded federal role in power-line siting. We lie between the coal fields in the Ohio River Valley, that likely would power new base-load generating plants built there, and New York and New Jersey, where the need for new power is most acute.

Consequently, Pennsylvania would be subjected to both the increased pollution that would drift north and east from any new coal-fired power plants in the Ohio Valley and the scarring of the landscape by massive new transmission lines.

And we get the feeling that officials and utilities in New York and New Jersey would be happy to place the burden of fulfilling their electricity needs on the good people of Pennsylvania and West Virginia. The new policy allows them to avoid making the hard choices with respect to providing for their own energy needs through new local generating facilities, increased conservation and efficiency.

That's a bad model for addressing the energy needs of the future in terms of environmental and financial costs. Quite possibly it makes the electric system more vulnerable to terrorist attack. But above all it creates a misleading sense among those who benefit from the costs imposed on others that they don't have to do anything on their part to keep their lights on.

Dear Commissioner Morrison:

The Board of Directors of Heritage Hunt, on behalf of the residents in our 1,600 home Active Adult Community in Gainesville, Virginia, have been systematically evaluating the proposal by Dominion Virginia Power, Allegheny Power, and PJM to build a 240 Mile, 500-kilovolt power line through Frederick, Warren, Fauquier, Prince William and Loudoun Counties., and the DOE plan to establish a NIETC corridor that would blanket northern Prince William County. We have attended Town Hall meetings, read extensively the reports and evaluations, and consulted with a variety of experts. Like many other residents in communities similar to our own that will be impacted, both visually and economically by this proposal, we are convinced, among other things, that:

- The absolute need for this power line has not been proven.
- There are alternative, less intrusive and less ecologically destructive solutions that should be pursued.
- Increased power can be obtained by the appropriate application of new technologies coupled with the expansion of the power generating capacity at the North Anna Nuclear facility.
- The proposed routes would unalterably deface some of the most historic and protected areas of the state and nation.
- Significant environmental and view shed impacts will occur as the transmission line cuts roughshod through neighborhoods causing significant economic harm to thousands of Virginia homeowners.
- A meaningful Demand Response program, energy efficiency initiatives, and an EIS study must be implemented before Dominion and its partners are authorized to proceed with this transmission line project.
- The effort to create a National Interest Electric Transmission Corridor in the PJM Interconnection service area, which would result in the use of federal eminent domain authority, tramples on the historically granted and guaranteed property rights of individuals.

At the core of our opposition to any and all of the alternative routes Dominion Virginia Power is considering is our firm belief that Dominion and PJM:

- **Have not** disclosed sufficient applicable facts despite repeated efforts by citizen groups to engage your company in two-way dialogue to demonstrate the need for the additional transmission capability you are proposing;
- **Have not** rigorously examined and applied available technology advances and improvements to existing power transmission lines that would help achieve the incremental transmission capabilities you say are needed to cover the few occasions when peak demand in Northern Virginia might exceed future system capacity;
- Have not taken appropriate action to implement demand-response strategies and to encourage electrical conservation measures that could alleviate the need for the new transmission capability altogether. It is well known that Virginia ranks **dead last among all states** in adopting electrical energy efficiency policies, and that Dominion Virginia Power's management leadership has chosen to foster and lobby for a continuation of generation and transmission practices that run counter to America's energy efficiency needs.

We believe it should be the responsibility of 21st century public utility companies to balance the quest for corporate profits and shareholder returns with the equally important responsibility to take an active leadership role in adopting and implementing energy generation and transmission policies that benefit its customers – we ratepayers – and that preserve and protect our environment and the scenic/historic Virginia land that is a central part of our nation's heritage. We believe that as stewards of shareholder interests, Dominion Power must also be stewards of the public trust. We urge the State Corporation Commission to respect and honor **your obligations to the public trust** and we encourage you to reject the Dominion application until all alternatives to the proposed transmission line have been thoroughly studied and reviewed as required by the 2005 Energy Policy Act.

A recently released best-seller is titled <u>The Audacity of Hope</u>. We, the residents of Heritage Hunt, have *the audacity to hope* that the leadership of Dominion Virginia Power and the State Corporation Commission will take our concerns and objections to heart . . . that you will engage in a meaningful, fact-based assessment that involves the public-at-large on this issue . . . and that you will choose to demand that Virginia's electricity providers must undertake aggressive energy efficiency programs and demand response services before authorizing the Dominion Power/PJM proposed 500 kilovolt transmission line.

I am writing to voice my opposition to Allegheny Power's plans to run a massive 330-mile, 500-kilovolt power line with 160-foot tall towers with 200-foot-wide rights-of-ways through our beautiful communities and countryside in Western Pennsylvania. I am concerned and disheartened about several issues listed below:

1. Is this power line really needed or is it about the powers company's bottom line and the profit there is to be made.

2. I am concerned about the unknown and known adverse short and long-term health effects from 500 KV power lines in close proximity to homes, farms and businesses. This line will cross through my brother's property (Carl R. Burkhardt at 138 Roberts Road Eighty Four, PA.) He recently bought this property in October 2007. He saved for 25 years and searched for 7 years to find this 20 acre farm. This is the first home he has ever owned. And although he knew there was an easement on this property he never imagined these types of massive power lines and towers would be coming through. These lines are designated to run if not right over his home then very close by. They also told him there is a good possibility he could have one or more towers placed on his property. Because his house is in the encroachment he is afraid of what will happen to his home. He is worried about the health effects these lines and towers will have on his future children.

3. I am concerned about the adverse health effects from the chemicals used to control overgrowth of weeds and shrubs around towers and under power line trails. These chemicals will pollute the air, land, livestock and watershed. I am a big supporter of shopping at the local farmers markets in Washington County. I will be concerned about buying these fruits and vegetables in the future if chemicals are used under these lines and around the towers.

4. I am concerned about the unsightly appearance of huge transmission lines and towers over our beautiful farmlands and neighborhoods. I recently drove by Buffalo, New York and was very disheartened by what I saw there in reference to all the power lines that run along the highway.

5. I am concerned about the restriction of our land use forever.

6. I am concerned about the decreased property values. Who will buy homes or farms with a huge tower on it and lines going overhead? If the power company does offer money for the land and houses where

will we go to replace our homes? There are not very many farms left at prices that can be afforded.

7. I do not believe the local economy will be helped by this when everyone starts to move out of the area to escape the dangers these lines, substation and towers will bring. New businesses and housing plans will not be built by these areas because of the unsightliness. The jobs created for the construction will be temporary and not have a long lasting impact on the job market in Western Pennsylvania.

8. The officials from Allegheny Power said our area needs the electricity because of the Meadows Casino's and Tangier Outlet Center coming to our area and also because more people are moving into Washington County. He said the goal is to supply reliable electric power to the company's customers even though I really know it is all about profits and the bottom line. Do they have to destroy everything in sight to accomplish this?
