# Instructions for Voluntary Terminations (VT's), Involuntary Terminations (IT's), and Voluntary Cancellations (VC's) of Tobacco Transition Payment Program (TTPP) Contracts and Report Selection Capabilities

#### 1 Overview

A Background

Notice TB-1230:

- provided instructions for entering VT's, IT's, and VC's
- **incorrectly** stated that BQL's from VC contracts will be made available for future contracts.

Note: This notice corrects the instruction for VC's provided in TB-1230.

Since the release of the associated software:

- the VC function has been used incorrectly on several contracts
- several questions have been received by the National Tobacco Processing Center (NTPC) and the technical staff in Kansas City.

This notice has been updated to correct these instructions. Users shall review this notice carefully to ensure that contracts are processed correctly. Forthcoming software will provide further confirmation of the action being taken and the resulting impact to the contract by providing additional messages.

#### 1 Overview (Continued)

#### A Background (Continued)

TTPP software:

- allows Service Center users to modify base quota level (BQL) shares paid erroneously; generating an underpayment or overpayment transaction for each year the shares were paid
- does **not** allow BQL's to be reduced to zero to make them available for other contracts

**Note:** It is necessary to be able to identify and track contracts that have been terminated at the request of the contract owner or because of TTPP requirement violations.

• "Cancel Contract" option is used to manage owner requested and violation cancellations.

**Notes:** "Cancel Contract" option deletes the contract and renders it unavailable in search results. TTPP software has been modified to allow Service Center users to enter:

- IT's using the BQL Correction process in Contract Maintenance
- VC's using the Update Contract process in Quota Holder Data or Producer Data Maintenance.

Contracts:

- will be updated with a terminated or canceled status and remain available in search results and reports
- resulting from a CCC-971 transaction will **not** be allowed to change to zero BQL at this time; this will be addressed with a future modification.

- obsoletes Notice TB-1230.

#### 2 Action

#### A County Office Action

County Offices shall:

- become familiar with new TTPP software that allows modifications to BQL's associated with unsold paid contracts
- become familiar with all new TTPP reports
- take action to correct contracts that require termination or cancellation
- obtain State Office approval for adjustments to the total farm BQL
- obtain State Office approval before processing an IT.

#### **B** State Office Action

State Offices shall:

- become familiar with the new TTPP software
- ensure that County Offices follow the provisions in this notice
- review and concur on all involuntary terminations before the County Office terminates the contract
- notify DAFP of contract terminated through IT's
- contact Michele Corcoran at 800-673-2331 with questions about this notice.

# **3** General Information – VT's, IT's, and VC's

#### A Overview

It is **important** to understand how the system will process contracts requiring VT's and IT's or VC's:

- VT's and IT's will be created using BQL Correction software
- VC's will be entered using Quota Holder Data or Producer Data Maintenance software.

**Note:** Once a contact has been voluntary/involuntary terminated or voluntarily canceled, the status **cannot** be changed. BQL's on VT or IT contracts will be made available for future contracts. BQL's on VC contracts will **not** be available for future contracts.

# **3** General Information – VT's, IT's, and VC's (Continued)

#### A Overview (Continued)

If it is determined that contracts were erroneously paid because of incorrect BQL's, users will continue to have the ability to access the approved contracts and adjust BQL values. See Notice TB-1231.

When Quota Holder Data or Producer Data Maintenance is used to change the status of a contract to VC, all future payments to the contract will be stopped. Receivables will **not** be created for any past payments to the contract. Once a contract owner voluntarily cancels a contract they should **not** be allowed to sign up for the same BQL at a later date. If a contract holder wants to voluntarily cancel their contract and return past payments, the Service Center user **must** use VT. The contract holder **must** request a VC or VT **in writing**. The County Office **must** attach the request to the original contract.

If the County Office believes a contract holder has misrepresented a fact affecting program determination or adopted a scheme or device to defeat the purpose of the program, the County Office should use IT. The following table provides additional detail.

**Notes:** When BQL changes for VT's or IT's are made and confirmed, TTPP will cancel the original contract and create a replacement contract. Both the original and replacement contracts will be displayed on the BQL Correction Update Successful Screen. The original contract will now be in canceled (CL) status and the new resulting contract will be in VT or IT status.

No new CCC-955/CCC-956's will be printed or signed by contract holders. All appeal rights **must** have been exhausted before a termination being processed.

When a contract is involuntarily terminated, the County Office **must** notify the State Office for concurrence **before** processing the termination. The State Office **must** inform DAFP of the contract termination.

# **B** Contract Status for VT's, IT's, and VC's

Only contracts in **approved** (AP) or **in-dispute** (DI) statuses can be terminated or canceled.

**Note:** Sold contracts are permanently locked. A forthcoming notice will provide instructions.

# **3** General Information – VT's, IT's, and VC's (Continued)

#### C Overpayment Processing

To ensure that overpayments (receivables) are processed in a timely fashion so they may be applied against future payments, the County Office should be aware of certain system requirements, see Notice **FI-2762**.

Since TTPP is a web-based system, an overpayment (receivable) generated from a modified TTPP contract will be transmitted back to the originating County Office. National Payment Services (NPS) uses a debt datamart to find and display receivable information. Overpayment information is transmitted by the originating County Office to NPS's datamart during end-of-day processing. To ensure that all outstanding TTPP receivables are accessible to NPS, ensure that end-of-day processing is performed **daily**.

# D Processing Treasury Checks Returned to the County Office

Deface the Treasury check by stamping or writing the words "**Void**" or "**Canceled**" across the face of the check and return the Treasury check to the following address:

#### E Report Request Menu

The individual reports are available through a "Reports" link. The reports link will access a Report Selection Criteria Menu that will provide the users with a wide report selection.

# 4 System Functionality

# A VC's

This is an example of the TTPP View Contract Results Screen. Service Center users may arrive at this screen from various screens depending on the contract type and the search criteria selected. The following example is of a Quota Holder Contract. The same process and screens will allow the user to cancel a Producer Contract.

To begin the Voluntary Cancellation Process the user will CLICK "**Update**" to view the Update Contract screen.

**Note:** BQL will not be available for future contracts. TTPP will not create receivables for any payments on the contract. If the contract owner wants to return payments, receivables **must** be created manually.

- cannot be the result of CCC-971.

**Note:** Because CCC-959 assignments are contract specific, users **must** take the following steps, according to 63-FI, before the contract can to be modified.

Step	Action
1	Require the assignee to revoke CCC-959.
2	Cancel the assignment attached to the contract to be corrected.
3	Access TTPP and modify the contract BQL according to procedures outlined in this notice; canceling the original contract and creating a new resulting contract.

#### **B** VT and IT Process (Continued)

When users CLICK "**Continue**" on the screen displayed on page 15, this Summary Screen will be displayed. This screen requires users to CLICK the radio box next to either of the following:

- "Voluntary Termination"
- "Involuntary Termination".

When BQL has been verified, CLICK "Submit".

#### **B** VT and IT Process (Continued)

When users CLICK "**Submit**" on the screen displayed on page 16, this Confirmation Screen will be displayed. When all information has been verified, CLICK "**Confirm**".

Since this adjustment reduces BQL, the system will generate an overpayment request (receivable) against each payment made against the contract when the termination is confirmed.
