## <u>REPORT AND ORDER</u> (Proceeding Terminated)

By the Chief, Video Services Division:

1. At the request of Channel 6, Inc. ("Channel 6"), licensee of station KCEN-TV, NTSC channel 6, Temple, Texas, the Commission has before it the <u>Notice of Proposed Rule Making</u>, 66 FR 12747, February 28, 2001, proposing the substitution of DTV channel 9 for station KCEN-TV's assigned DTV channel 50. Channel 6 filed comments restating its intention to apply to operate a DTV station on channel 9 in Temple, Texas. No other comments were filed.

2. We believe the public interest would be served by adopting Channel 6's proposal because, according to Channel 6, it would permit comparable coverage of station KCEN-DT's service area at a far lower cost. DTV channel 9 can be allotted to Temple, Texas, as proposed, in compliance with the principle community coverage requirements of Section 73.625(a) at coordinates (31-16-24 N. and 97-13-14 W.). In addition, we find that this channel is acceptable under the 2 percent criterion for *de minimis* impact that is applied in evaluating requests for modification of initial DTV allotments under Section 73.623(c)(2) for Station KCEN-TV with the following specifications:
