Dear Ms. Dortch:

On January 31, 2008, John Eck, President, NBC Television Network, and Chief Information Officer, NBC Universal, Inc. ("NBCU"); Glenn Reitmeier, Vice President, Technology Policy, NBCU; Bill LeBeau, Senior Regulatory Counsel, NBCU; and the undersigned met with Commissioner Michael Copps and Rick Chessen, senior legal advisor and media advisor to Commissioner Copps, to discuss certain matters addressed in the Joint Comments and Reply Comments of the Association for Maximum Service Television, Inc. and the National Association of Broadcasters filed on January 31, 2007, and March 2, 2007, respectively, in the Commission's above-referenced proceeding examining unlicensed operation in the television broadcast bands. NBCU and Telemundo are members of MSTV and the NAB. On the same day, Mr. Eck, Mr. Reitmeier, the undersigned, and Bob Okun, Vice President, Government Relations, NBCU, met with Commissioner Jonathan Adelstein and his media advisor, Rudy Brioché, and Commissioner Robert McDowell, and his media advisor, Cristina Chou Pauzé, to discuss these matters.

The NBCU parties urged the Commission to exercise great caution in adopting any new rules concerning devices operating in the TV bands that might compromise DTV interference protections, the success of the digital transition, and the promise of new services to be introduced by television licensees, including mobile and handheld services using digital television signals. The parties discussed the ongoing work of the Open Mobile Video Coalition and the Advanced Television Systems Committee in developing new standards and hardware for these new services.
