4	SEC. 2. PROVISION OF SPECIALLY ADAPTIVE HOUSING AS-
5	SISTANCE TO DISABLED MEMBERS OF THE

14	"(c) Assistance for Members of the Armed

16	subsection (a) to a member of the Armed Forces serving
17	on active duty who is suffering from a disability described

in subsection (a)(2) or (b)(2) of section 2101 of this title 1 if such disability is the result of an injury incurred or dis-2 3 ease contracted in or aggravated in line of duty in the 4 active military, naval, or air service. Such assistance shall 5 be provided to the same extent as assistance is provided under subsection (a) to veterans eligible for assistance 6 7 under that subsection and subject to the limitation under 8 subsection (c).".

9 SEC. 3. EXTENSION OF PERIOD OF MORTGAGE FORE-10CLOSURE11SERVICEMEMBERS CIVIL RELIEF ACT.

(a) EXTENSION TO 6 MONTHS.—Subsection (c) of
section 303 of the Servicemembers Civil Relief Act (50
U.S.C. App. 533(c)) is amended by striking "90 days"
and inserting "180 days".

(b) EXTENSION OF PERIOD OF INTEREST RATE LIM17 ITATION.—Such section is further amended by adding at

16 "§ 7691. Authority for program

"As part of the Educational Assistance Program and 17 18 subject to the availability of appropriations for such purpose, the Secretary shall carry out a scholarship program 19 under this subchapter. The program shall be known as the 20 21 Department of Veterans Affairs Visual Impairment and 22 Orientation and Mobility Professionals Scholarship Pro-23 gram (hereinafter in this subchapter referred to as the 24 'Program'). The purpose of the Program is to increase the

supply of qualified blind rehabilitation specialists for the
 Department and the Nation.

3 "§ 7692. Eligibility; agreement

4 "(a) ELIGIBILITY.—To be eligible to participate in
5 the Program, an individual must be accepted for enroll6 ment or enrolled (as described in section 7602 of this title)
7 as a full-time or part-time student in a field of education
8 or training described in subsection (b).

9 "(b) QUALIFYING FIELDS OF EDUCATION OR TRAIN10 ING.—A field of education or training described in this
11 subsection is education or training leading to—

"(1) a degree or certificate in visual impairment
or orientation and mobility, or a dual degree or certification in both such areas; and

15 "(2) appointment or retention in a position16 under section 7401 of this title.

17 "(c) AGREEMENT.—(1) An agreement between the
18 Secretary and a participant in the Program shall (in addi19 tion to the requirements set forth in section 7604 of this
20 title) include the following:

"(A) The Secretary's agreement to provide the
participant with a scholarship under the Program
for a specified number (from one to three) of school
years during which the participant pursues a course
of education or training described in subsection (b)

that meets the requirements set forth in section
 7602(a) of this title.

"(B) The participant's agreement to serve as a 3 4 full-time employee in the Veterans Health Adminis-5 tration for a period of three years (hereinafter in 6 this subchapter referred to as the 'period of obli-7 gated service') during the six-year period beginning 8 on the date the participant completes the education 9 or training and receives a degree or certificate de-10 scribed in subsection (b)(1).

"(C) The participant's agreement to serve
under subparagraph (B) in a Department facility selected by the Secretary.

14 "(2) In a case in which an extension is granted under 15 section 7673(c)(2) of this title, the number of years for 16 which a scholarship may be provided under the Program 17 shall be the number of school years provided for as a result 18 of the extension.

19 "(3) In the case of a participant who is a part-time 20 student, the period of obligated service shall be reduced 21 in accordance with the proportion that the number of cred-22 it hours carried by such participant in any such school 23 year bears to the number of credit hours required to be 24 carried by a full-time student in the course of training

being pursued by the participant, but in no event to less
 than one year.

3 "§ 7693. Scholarship

4 "(a) SCHOLARSHIP.—A scholarship provided to a 5 participant in the Program for a school year shall consist 6 of payment of the tuition (or such portion of the tuition 7 as may be provided under subsection (b)) of the partici-8 pant for that school year and payment of other reasonable 9 educational expenses (including fees, books, and labora-10 tory expenses) for that school year.

11 "(b) AMOUNTS.—The total amount of the scholarship12 payable under subsection (a)—

"(1) in the case of a participant in the Program
who is a full-time student, may not exceed \$15,000
for the equivalent of one year of full-time
coursework; and

17 "(2) in the case of a participant in the Program 18 who is a part-time student, shall bear the same ratio 19 to the amount that would be paid under paragraph 20 (1) if the participant were a full-time student in the 21 course of education or training being pursued by the 22 participant as the coursework carried by the partici-23 pant to full-time coursework in that course of edu-24 cation or training.

"(c) LIMITATIONS ON PERIOD OF PAYMENT.—(1)
 The maximum number of school years for which a scholar ship may be paid under subsection (a) to a participant
 in the Program shall be six school years.

5 "(2) A participant in the Program may not receive
6 a scholarship under subsection (a) for more than the
7 equivalent of three years of full-time coursework.

8 "(d) PAYMENT OF EDUCATIONAL EXPENSES BY 9 EDUCATIONAL INSTITUTIONS.—The Secretary may ar-10 range with an educational institution in which a partici-11 pant in the Program is enrolled for the payment of the 12 educational expenses described in subsection (a). Such 13 payments may be made without regard to subsections (a) 14 and (b) of section 3324 of title 31.

15 "(e) FULL-TIME COURSEWORK.—For purposes of
16 this section, full-time coursework shall consist of the fol17 lowing:

18 "(1) In the case of undergraduate coursework,19 30 semester hours per undergraduate school year.

20 "(2) In the case of graduate coursework, 18 se21 mester hours per graduate school year.

22 "§ 7694. Obligated service

23 "(a) IN GENERAL.—Each participant in the Program
24 shall provide service as a full-time employee of the Depart25 ment for the period of obligated service provided in the

agreement of the participant entered into under section
 7604 of this title. Such service shall be provided in the
 full-time clinical practice of such participant's profession
 or in another health-care position in an assignment or lo cation determined by the Secretary.

6 "(b) DETERMINATION OF SERVICE COMMENCEMENT 7 DATE.—(1) Not later than 60 days before a participant's 8 service commencement date, the Secretary shall notify the 9 participant of that service commencement date. That date 10 is the date for the beginning of the participant's period 11 of obligated service.

12 "(2) As soon as possible after a participant's service13 commencement date, the Secretary shall—

"(A) in the case of a participant who is not a
full-time employee in the Veterans Health Administration, appoint the participant as such an employee;
and

"(B) in the case of a participant who is an employee in the Veterans Health Administration but is
not serving in a position for which the participant's
course of education or training prepared the participant, assign the participant to such a position.

23 "(3)(A) In the case of a participant receiving a de24 gree from a school of medicine, osteopathy, dentistry, op25 tometry, or podiatry, the participant's service commence-

ment date is the date upon which the participant becomes
 licensed to practice medicine, osteopathy, dentistry, op tometry, or podiatry, as the case may be, in a State.

4 "(B) In the case of a participant receiving a degree
5 from a school of nursing, the participant's service com6 mencement date is the later of—

7 "(i) the participant's course completion date; or
8 "(ii) the date upon which the participant be9 comes licensed as a registered nurse in a State.

10 "(C) In the case of a participant not covered by sub11 paragraph (A) or (B), the participant's service commence12 ment date is the later of—

"(i) the participant's course completion date; or
"(ii) the date the participant meets any applicable licensure or certification requirements.

"(4) The Secretary shall by regulation prescribe the
service commencement date for participants who were
part-time students. Such regulations shall prescribe terms
as similar as practicable to the terms set forth in paragraph (3). (c)

21 "(c) COMMENCEMENT OF OBLIGATED SERVICE.—(1)
22 Except as provided in paragraph (2), a participant in the
23 Program shall be considered to have begun serving the
24 participant's period of obligated service—

1 "(A) on the date, after the participant's course 2 completion date, on which the participant (in accord-3 ance with subsection (b)) is appointed as a full-time 4 employee in the Veterans Health Administration; or 5 "(B) if the participant is a full-time employee 6 in the Veterans Health Administration on such 7 course completion date, on the date thereafter on 8 which the participant is assigned to a position for 9 which the participant's course of training prepared 10 the participant.

11 "(2) A participant in the Program who on the partici-12 pant's course completion date is a full-time employee in 13 the Veterans Health Administration serving in a capacity 14 for which the participant's course of training prepared the 15 participant shall be considered to have begun serving the 16 participant's period of obligated service on such course 17 completion date.

"(d) COURSE COMPLETION DATE DEFINED.—In this
section, the term 'course completion date' means the date
on which a participant in the Program completes the participant's course of education or training under the Program.

1 "§ 7695. Repayment for failure to satisfy require-2 ments of agreement

3 "(a) IN GENERAL.—An individual who receives educational assistance under this subchapter shall repay to 4 5 the Secretary an amount equal to the unearned portion of such assistance if the individual fails to satisfy the re-6 7 quirements of the agreement entered into under section 8 7604 of this title, except in circumstances authorized by 9 the Secretary.

10 "(b) Amount of Repayment.—The Secretary shall 11 establish, by regulations, procedures for determining the amount of the repayment required under this subsection 12 13 and the circumstances under which an exception to the required repayment may be granted. 14

15 "(c) WAIVER OR SUSPENSION OF COMPLIANCE.— 16 The Secretary shall prescribe regulations providing for the waiver or suspension of any obligation of an individual for 17 18 service or payment under this subchapter (or an agree-19 ment under this subchapter) whenever noncompliance by 20the individual is due to circumstances beyond the control 21 of the individual or whenever the Secretary determines 22 that the waiver or suspension of compliance is in the best 23interest of the United States.

24 "(d) Obligation as Debt to United States.— An obligation to repay the Secretary under this section 25 is, for all purposes, a debt owed the United States. A dis-26 (381256|3)
