# Introduction

The Pharmacy Prescription Practices package provides VA medical centers with the ability to determine at what other VA medical facilities a patient has been seen and to request current pharmacy data from those facilities prior to the patient appearing for a scheduled outpatient visit.

It is recommended you slave print the installation process. The data printed out during the post-init should be reviewed.

# **Package Integration**

The following package versions (or higher) must be installed prior to loading this version of PPP.

Patch PSO\*6\*105 is required for the installation of PPP. The routines included in this patch are PSOBBC PSONUM PSOPRF PSORX PSOSD.

### Package Initialization/Conversion Time Estimates

The following information was derived from our alpha sites. The times presented are averages. Actual times may vary, depending on system utilization. The total install process, on average, takes an hour or less.

A facility with a 60,000 patient database would see the following impact given 10 percent of the population is mobile.

Size of ^PPP:	63 x 6,000 = 3.78 Kb
Increase in ^VAT:	$10,240 \ge 6,000 = 61.4$ megabytes
Increase in ^XMB:	42 x 6,000 = 2.52 Kb
Total increase disk capacity:	62 megabytes
Increase in network traffic:	$12 \ge 6,000 = 7.2$ Kb/days

**NOTE:** Global Growth can be controlled by the purge features of PPP and PDX. Sites will see an increase in IDCU traffic.

# **Installation Checklist**

- **1**. Request users be off the system [optional].
- **2**. Backup system(s) [optional].

□ 7. There is a new global, ^PPP. This global contains File #s 1020.1 through 1020.8. This global MUST be placed with the appropriate protection assigned to it before running the PPPINIT inits. Refer to the Resource Requirements section of this Installation Guide concerning global growth to determine the most appropriate place for this new global.

NOTE: For MSM systems, set ^PPP="" on the desired system and then use %GCH to set proper protection on the new global.

### **D** 8. **D ^ PPPINIT**

Please answer all initialization questions carefully. It is strongly recommended you take the bolded responses from the guide.

**Note:** At the end of the process a mail message is sent to the development ISC indicating that the install is complete.

- 9. Delete the initialization routines PPPIN\*, PPPON\*, and PPPPSL\*. Do **not** delete PPPINITY.
- **1**0. MSM sites will need to move the PPP routines to all nodes.
- □ 11. Whoever schedules the Prescription Practices Daily Batch Routine [PPP BATCH] needs to set their DUZ to .5 (POSTMASTER) before entering the TaskManager option. This is done to associate the PDXs generated from this batch job with the POSTMASTER. Setting the DUZ to .5 is not required for the job to function properly but is recommended.

If the job fails and requires rescheduling, this procedure should be followed to insure the correct DUZ is associated with the PDXs.

Run the Build/Rebuild Other Facility Xref [PPP BUILD FFX] option 14. from the Prescription Practices Utilities [PPP MAIN] menu. This option initializes the PPP FOREIGN FACILITY XREF file (#1020.2). This option needs to be run at initialization and each time a new MPD CD-ROM is issued. The background will run approximately 2 seconds for each SSN listed in the "B" cross-reference in the local PATIENT file, which equates to approximately 17 hours for a 30,000 patient database. While this option is running, the PPP FOREIGN FACILITY XREF file is locked and cannot be manually edited. It is recommended that this option be scheduled to run over the weekend when system activity is low. For more detailed instruction on running this option, see the PPP V. 1.0 User Manual and the MPD V. 1.0 User Manual.

### **Attachment C - PPP Parameter File**

The PPP PARAMETER file (#1020.1) establishes the local operating parameters for the Pharmacy Prescription Practices package. It consists of fifteen fields. Eleven of those fields (listed below) may be edited during the installation process.

### PRE-CLINIC SCAN DAYS

Once each day, the Pharmacy Prescription Practices software will scan the clinic schedule for any patients in the PPP FOREIGN FACILITY XREF file (#1020.2) who are scheduled for clinic appointments. This field determines how many days in the future to scan the HOSPITAL LOCATION file (#44). For example, if you want the software to scan for appointments one week in the future, you should enter 7 in this field.

#### DAYS PDX DATA VALID

If the Pharmacy Prescription Practices software finds a patient in the PPP FOREIGN FACILITY XREF file who is scheduled for a clinic appointment, it will attempt to send a PDX request to the other facilities visited by that patient. This request will not be sent if PDX data already exists for this patient, unless the data on file is older than the number of days specified in this field.

#### MPD EXTENDED ADDRESS

This field contains the volume set and UCI for the location of the MPD server.

#### PRINT CLINIC PROFILE

The Pharmacy Prescription Practices software is capable of printing a medication profile, including both local and other facility data, for every patient scheduled for clinic on a given day. The report is enabled by setting this field to YES, and disabled by setting it to NO. An example of the clinic profile is provided in Appendix B of the PPP User Manual.

#### PRINT ALL PROFILES

If the PRINT CLINIC PROFILE field is set to YES, you have the option of printing profiles for all scheduled patients or only those with medication data from other facilities. To print medication profiles for <u>all</u> scheduled patients, set this field to YES. To print <u>only</u> profiles for patients with data from other facilities, set this field to NO. An example of the medication profile is provided in Appendix B of the PPP User Manual.

### LOCAL STATION NUMBER

Enter the station number of your VA medical center.

### PRE-CLINIC PRINT DAYS

This field determines the number of days in advance of the clinic appointments to print the profile report. For example, if you want the report printed three days prior to the scheduled clinic appointments, enter a 3 in this field.

### LOGFILE RETENTION DAYS

This field indicates the number of days you want to keep data in the PPP LOG file (#1020.4) when using the Purge Log File option. For example, if you wish to retain the last ten days in the PPP LOG file, enter 10 in this field.

### XREF RETENTION DAYS

This field indicates the number of days you want to keep data in the PPP FOREIGN FACILITY XREF file when using the Purge Other Facility Xref option. The data purged is based on the LAST DATE OF VISIT field. For example, if you wish to purge all entries for patients who have not been to another facility in the past year, enter 365 in this field.

### LOCATION OF DPT GLOBAL

This field contains the volume set and UCI for the DPT Global origination point.

### LOCATION OF TMP GLOBAL

This field contains the volume set and UCI for the TMP Global origination point.
