1 Overview

A Background

Notice DAP-32 notified the State and County Offices that:

- the National Office and KCMO would temporarily cease processing crop tables submitted by Excel or Lotus spreadsheets on May 5, 1999
- the crop tables as of COB May 7, 1999, would be posted to the CLDAP Library on BBS on May 10, 1999.

B Purpose

This notice provides State Offices with instructions for adding and correcting the existing CLDAP crop table.

B Correcting CLDAP Crop Table

On May 10, 1999, 2 crop table files will be posted to the CLDAP Library for each State Office; all other files have been archived and removed. The 2 files will be zipped and contain identical information, except they will contain the following file formats:

- Excel 3.0, named SS.zip
- WordPerfect 6.1, named stSSwpb.zip

Note: SS is the State code.

State Offices:

- shall review the crop table in either format but must submit additions and corrections as soon as possible but no later than May 17, 1999, to the BBS CLDAP Library in the Excel format
- shall name the upload file SSa.zip
- **must** submit **only 1** crop table file with the additions and corrections to the CLDAP Library.

Note: The first column of the Excel spreadsheet must be coded with an "S" to indicate the changed or added records. PECD will process records in the order received.

The first record of the Excel spreadsheet contains the headings for the crop table. **Do not** add, delete, or revise these headings as they are essential to the processing of the data base tables. All other records can be changed or added.

Note: Crop table files submitted through e-mail, FAX, or any way other than the CLDAP Library, or not in the Excel format, **will not** be accepted.

C Correcting CLDAP Errors

After careful review and correction of the CLDAP crop table is completed by the State Office and placed in the CLDAP Library, the PECD Program Specialist will process the file for transmission to KCMO. If errors in the crop table file are found by PECD or KCMO processing, the National Office shall assign a PECD Program Specialist to assist the State Office in making correction to the crop table file.

The specific PECD Program Specialist will be the primary contact for the State Office concerning the crop table file and work with the State Office until the crop table file is accurate and complete.

A future notice will explain the error files and correction process.

Crop Table Field Validations

The following table is a complete field-by-field description of the required fields in the CLDAP crop data file. The field names are the 1st record of the Excel spreadsheet.

Note: All text must be in capital letters.

State Code	Required with no leading 0's.		
County Code	Required with no leading 0's.		
Crop Code	Required with no leading 0's and must be a valid crop code for 1998.		
Crop Abbr	Required and must be in 2-CP, Exhibit 10.		
Type Abbr	Required and must be in 2-CP, Exhibit 10.		
Intended Use	Required and must be in 2-CP, Exhibit 10.		
FSA Prac	Required, except for value loss crops, and must be either I or N.		
NASS Prac	Leave blank.		
RMA Prac	Required to process insured crops.		
RMA Crop	Required to process insured crops.		
RMA Type	Required to process insured crops.		
County Yield	Yield approved by STC to be used in the payment calculation.		
Yield Code	Required and numbers 1-5 for number of years of records or S for STC approved.		
Unit of Measure	Required and must be 1 of the following:

Planting	Required, except for value loss crops, and must be between 1 and 99.
Final Planting	Leave blank.
Price	Price approved to be used in the payment calculation.
Price Code	Leave blank.
Prevented	Required and must be in decimal format.
Prev Code	Leave blank.
Unharvested	Required and must be in decimal format.
Unharv Code	Leave blank.
Harvested	Must be 1.
