UNANIMOUS CONSENT AGREEMENTS

H.R. 2419 (ORDER NO. 339)

1.—Ordered, That on Wednesday, December 12, 2007, upon the conclusion of Morning Business, the Senate resume consideration of H.R. 2419, an act to provide for the continuation of agricultural programs through fiscal year 2012, and for other purposes.

Ordered further, That the Senate proceed to vote on Amdt. No. 3671 and Amdt. No. 3672, offered by the Senator from New Hampshire (Mr. Gregg); provided that no amendments be in order to the amendments prior to the vote, and that there be two minutes of debate prior to each vote, equally divided and controlled; provided further that the second vote be 10 minutes in duration.

Ordered further, That the following amendments be debated for the time limits specified, with all time equally divided and controlled in the usual form, with no amendments in order to any amendments covered under the agreement prior to a vote in relation to the amendment:

Amdt. Nos. 3551 and 3553, offered by the Senator from Tennessee (Mr. Alexander), with 30 minutes divided as follows: 10 minutes each Senators Alexander, Bingaman and Salazar;

Amdt. No. 3687, offered by the Senator from Texas (Mr. Cornyn)-30 minutes; Amdt. No. 3695, as modified, offered by the Senator from North Dakota (Mr. Dorgan) and the Senator from Iowa (Mr. Grassley)—2 hours:

Amdt. No. 3810, offered by the Senator from Minnesota (Ms. Klobuchar)-60 min-

utes;

Amdt. No. 3673, offered by the Senator from New Hampshire (Mr. Gregg)—2 hours; Amdt. No. 3596, offered by the Senator from Alabama (Mr. Sessions)—40 minutes: 10 minutes for the proponent and 20 minutes for the opposition;

Amdt. Nos. 3807, 3530, and 3632, offered by the Senator from Oklahoma (Mr.

Coburn)—90 minutes.

Ordered further, That the following amendments be subject to a 60 vote threshold, and if the amendment achieves the 60 votes then it be agreed to and the motion to reconsider be laid upon the table; that if the amendment fails to achieve 60 votes then it be withdrawn: Amdt. No. 3695, Amdt. No. 3673 and Amdt. No. 3810.

Ordered further, That in any vote sequence, there be two minutes of debate equally divided prior to each vote, and that after the first vote in any sequence, the succeeding

votes be limited to 10 minutes.

Ordered further, That the vote on Amdt. No. 3695 occur at 9:15 a.m. on Thursday,

December 13, 2007.

Ordered further, That the cloture vote on Amdt. No. 3500, offered by the Senator from Iowa (Mr. Harkin), H.R. 2419, occur at a time to be determined by the Majority Leader, after consultation with the Republican Leader.
