1 The Agency is in the process of revising its complaint tracking system so that it calculates processing time in compliance with the Equal Employment Opportunity Commission's (EEOC) recent guidance on complaints held in abeyance. The average length of time to complete investigations include the number of days certain complaints were in the abeyance stage, thus extending the length of time beyond the regulatory requirement.

2 The total number of complaints pending that were filed prior to the start of this fiscal year is more than the total number of individuals who filed those complaints because some individuals filed more then one complaint and EEOC Regulations allow for the joint processing and consolidation of complaints. Under 29 C.F.R. § 1614.606, complaints of discrimination filed by two or more complainants consisting of substantially similar allegations of discrimination or relating to the same matter may be consolidated by the Agency for joint processing. In addition, two or more complaints of discrimination filed by the same complainant shall be consolidated by the Agency for joint processing. *Id* [6].
